As per the Examination Wing's at Headquarters office, it is intimated that the Examination – 2 of 2021 has been called off and the next SAS/RA/I/CPD exam will be the Examination – 1 of 2022 which will be conducted from 18th to 23rd April, 2022. The Online registration for the same will also start in due course.

- 1. Applications are invited from eligible candidates intending to appear in the SAS/IE/CPD Examination 1 of 2022. The cut-off date for determining the eligibility of the officials for SAS/IE/CPD Examinations will be 1st of March, 2022 for Examination -1 of 2022, unless otherwise notified by the competent authority in a particular year.
- 2. All the candidates who have submitted their Pre-registration form for the Examination-2 of SAS/RA/I/CPD-2021 (list attached below) will now be used for the next exam of Examination – 1 of 2022. They do not need to send the pre-registration form again.
- 3. Candidates who are intending to appear in the SAS/RA/I/CPD Examination 1 of 2022 and have not send their pre-registration form or have missed the due date for form submission, called for Examination 2 of 2021, or have become eligible for the Examination-1 of 2022 can only fill in the form.
- 4. All the candidates who have passed the SAS (Civil Audit) Exam and have not applied for deputation-cum-absorption basis or have not been absorbed in Audit Offices can also apply for the Civil Accounts Examination, (along with the written undertaking that they agree to forfeit their claim for deputation-cum eventual absorption in any Civil Audit Office) by filling up the Pre-Registration form from the office website, and furnishing the details and the Index No. and year, by which they have passed the Civil Audit Exam.
- 5. SAS Candidates who have exhausted 10 chances will be allowed two more chances within 02 years counting from Examination-1 of 2021.
- 6. All the fresh SAS candidates & the CPD are required to attend the pre-requisite Training as their Training Completion certificate will be sent to Headquarters, without which they will not be permitted to appear in the Examination.
- 7. All the existing candidates who have previously registered in the CBT from the Main Exam of 2019 and later, have to compulsorily mention their correct LOGIN ID (to be get from the <u>Admit card</u>), using which they have registered for the exam.
- 8. If the candidate has appeared last time in CBT, before Mains 2019 Exam, then they have to correctly mention the Last Exam in which appeared & the correct Index Number allotted for that Examination. In case of incomplete/wrong information is given, then registration for the exam will not be possible.
