The enhanced rate of Dearness Relief is payable alongwith the pension with effect from 01.01.2023, 01.07.2023 and 01.01.2024. The State Judicial Pensioners/family pensioners who are continuing to draw their pension in the pre-revised scale as per 6th CPC may be paid Dearness Relief @221% with effect from 01.01.2023 and 230% with effect from 01.07.2023. The arrears of account of the enhanced Dearness Relief with effect from 01.01.2023, 01.07.2023 and 01.01.2024 may be paid in cash. Payment of Dearness Allowance / Dearness Relief to State Judicial Officers / State Judicial Pensioners – Revised Rates effective from 01.01.2023 and 01.07.2023 – Orders Issued.

FINANCE (PAY RESEARCH UNIT) DEPARTMENT

G.O.(P)No.15/2024/FIN Dated, Thiruvananthapuram, 11-03-2024

Read: 1. O.M.No.1/1/2023-E.II(B) dated 03.04.2023 and O.M.No.1/4/2023-E.II(B) dated 20.10.2023 of the Department of Expenditure, Ministry of Finance, Government of India.

2. O.M.No.1/3(1)/2008-E.II(B) dated 10.04.2023 and 06.11.2023 of the Department of Expenditure, Ministry of Finance, Government of India.

ORDER

As per Office Memoranda read as 1st above, Government of India enhanced the rate of Dearness Allowance payable to the Central Government employees from 38% to 42% w.e.f. 01.01.2023 and 42% to 46% w.e.f. 01.07.2023 respectively. Also as per Office Memoranda read as 2nd above, the rate of Dearness Allowance payable to the Central Government employees continuing to draw their pay in the pre-revised scale as per 6th CPC has also been enhanced from 212% to 221% w.e.f. 01.01.2023 and from 221% to 230% w.e.f. 01.07.2023.

Hence, the rate of Dearness Allowance/Dearness Relief payable to State Judicial Officers / State Judicial Pensioners will be enhanced as follows:

Date of effect	Rate of DA/DR
01.01.2023	42%
01.07.2023	46%

The rate of Dearness Allowance/Dearness Relief payable to State Judicial Officers / State Judicial Pensioners who are continuing to draw their

pay/pension in the pre-revised scale as per 6th CPC will be enhanced as follows:

Date of effect	Rate of DA/DR
01.01.2023	221%
01.07.2023	230%

The Dearness Allowance/Dearness Relief at the enhanced rates will be paid along with the salary/pension for the month of April 2024.



ORDER

As per Government Order read above, the Dearness Allowance / Dearness Relief payable to State Judicial Officers / State Judicial Pensioners has been enhanced to 42 % w.e.f. 01.01.2023 and 46% w.e.f. 01.07.2023 and to those who are continuing to draw their pay/pension in the pre-revised scale has been raised to 221 % w.e.f. 01.01.2023 and 230% w.e.f. 01.07.2023.

2. Government are pleased to incorporate the following clause in the GO read above: "The arrears on account of the enhanced Dearness Allowance / Dearness Relief w.e.f. 01.01.2023 and 01.07.2023 shall be paid in cash".
3. The Government Order read above stands modified to this extent.

ORDER

Consequent to the revision of pension/family pension and other related benefits of State Government pensioners and family pensioners as per Government Order read (4) and (5) above, Government are pleased to revise the rate of pension/family pension in respect of persons directly recruited to the personal staff of Chief Minister, Ministers, Leader of Opposition and Government Chief Whip as follows:

i) In the case of those who retire on or after 01/07/2019, the pension shall be worked out on the basis of average emoluments on the revised scale of pay with full pension of 50% of average emoluments for 30 years of service and proportionate reduction for service less than 30 years.

ii) The minimum rate of pension/family pension is enhanced to ₹3,350/- per month and is applicable to all who are now in receipt of minimum pension.

iii) The maximum pension will be ₹83,400/- (ie. maximum pension of state pensioners).

iv) In the case of those who were in receipt of pension prior to 01/07/2019, their pension shall be revised by multiplying the existing basic pension as on 30/06/2019 by a factor of 1.38 and rounded to the next multiple of 10.

v) The Medical allowance to the pensioners/family pensioners shall be enhanced to ₹500/- per month, w.e.f 01/04/2021.

vi) 'Special Care Allowance' @ ₹1,000/- per month shall be granted to the Pensioners/ Family Pensioners on completion of 80 years of age with effect from 01/04/2021. No Dearness Relief is admissible for Special Care Allowance.

Example:- A pensioner born on 24/07/1941 completes 80 years on 23/07/2021. He shall be eligible for this allowance from August 2021 onwards.

vii) Arrears on account of Pension/Family pension, DCRG, Commutation, Terminal Surrender shall be disbursed as in the case of State Service Pensioners vide Government Order read 5th above.

viii) The existing rules on calculating Commutation and DCRG will continue.

ix) Dearness Relief shall be allowed as in the case of State Service Pensioners.

x) The date of effect of this order shall be from 01/07/2019.
