# OFFICE MEMORANDUM

Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.07.2024-reg

The undersigned is directed to refer to this Department's OM No. 42/02/2024-P&PW(D) dated 13.03.2024 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 50% to 53% of the basic pension/family pension (including additional pension/family pension) w.e.f 01st July, 2024.

- These rates of DR will be applicable to the following categories:-2.
- Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
- All India Service Pensioners/Family Pensioners. (iii)
- Railway Pensioners/Family Pensioners. (iv)
- Pensioners who are in receipt of provisional pension (v)
- The Burma Civilian Pensioners/Family Pensioners and Pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11 09.2017.
- The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/family pension of October, 2024.

- Other provisions governing grant of DR in respect of employed family pensioners and reemployed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 6. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 7. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528- TA, II/34-80-II dated 23/04/198) of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21 st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 9. In so far as the pensioners/family pensioners of Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.
- 10. This issues in accordance with the Ministry of Finance, Department of Expenditure's OM No. 1/5/2024-E-II(B) dated 21.10.2024 and approval of C&AG vide ID Note No. भारत के नि.म.ते.प.यू.ओ.सख्या-339 स्टाफ हक (नियम)/AR/02-2020) dated 30.10.2024.

Sir,

I am directed to refer to this department's letter of even number dated 27<sup>th</sup> March, 2024 on the above subject and to say that consequent upon grant of further Dearness Relief (DR) on pension/family pension to the employees of Central Government and Central Autonomous Bodies vide Department of Pension & Pensioners Welfare's O.M. No. 42/02/2024- P&PW(D) dated 30<sup>th</sup> October, 2024 (Copy enclosed), it has been decided that retired Judges of Supreme Court/High Courts and family pensioners of such Judges would be entitled to Dearness Relief on pension/family pension at the rate of 53% of the basic pension/family pension (including additional pension/ family pension) with effect from 1<sup>st</sup> July, 2024.

- 2. The payment on account of Dearness Relief involving a fraction of a rupee shall be rounded to the next higher rupee.
- 3. The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/ family pension of October, 2024.
- 4. The provision governing grant of Dearness Relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.

- 5. Other provisions contained in this Department's letter No. L-19016/3/97-Jus. dated 13<sup>th</sup> January, 1999 will remain unchanged.
- 6. Accountant Generals/Pay and Accounts Officers are requested to arrange payment of dearness relief to the pensioners on the basis of the aforesaid instructions as per the procedure adopted by the Department of Pension & Pensioners' Welfare without any further delay.
- 7. This issues with the concurrence of Additional Secretary and Financial Advisor (Law & Justice) vide Note No. 168 dated 13.11.2024 (e-file no. 3834) and approval of Secretary (Justice) vide Note No. 172 dated 18.11.2024.

# NOTIFICATION

WHEREAS, the State Government has already framed a Scheme for Post Retiral Benefits of the Retired Chief Justices and Retired Judges of the High Court of Tripura for defraying the services of an Orderly, Driver, Security Guard, Secretarial Assistance etc. and for a free of cost Residential Telephone, vide this Department's Notification No.F.2(7)-LAW/ESTT.2/2013/4648-58 dated 01.07.2015, in compliance with the Judgment and Order of the Hon'ble Supreme Court of India in Case No.WP (C) 521/2002 etc. dated 31.03.2014 and in accordance with the resolution of the Joint Conference of the Chief Ministers of States and Chief Justices of the High Courts held on 18.09.2004 and further an Addendum dated 15.12.2017 was issued vide No.F.2(7)-LAW/ESTT.2/2013 on the question of authorizing Pension Disbursing officer to draw & disburse the expenses of domestic help(s) etc. and residential telephone calls expenses etc.;

AND WHEREAS, the Hon'ble Supreme Court vide Order dated 18.02.2025 passed in Conmt. Petition (C) No.425-426/2015 in WP(C) 523/2002 ( Justice V. S. Dave, President, the Association of Retired Judges of Supreme Court and High Courts Vs. Kusumjit Sidhu & Ors.) has directed all the State Governments and Union Territories to make available the facility on the issue of domestic help(s) and telephone bill reimbursement to the retired Judges as are provided in the State of Andhra Pradesh in view of their earlier order dated 01.05.2017 and if after the said order, the Andhra Pradesh Government is giving better facilities to the retired Judges in that State, the same must also be extended by all the States and Union Territories;

AND WHEREAS, the State Government has received a copy of the G.O.Ms. No.5 dated 10.01.2022 of the Andhra Pradesh Government Notification styled as "the Retired Chief Justices and Judges Domestic Help(s) and Other Benefits Rules, 2021";

NOW THEREFORE, the Government of Tripura, in compliance of the directions of the Hon'ble Supreme Court of India given in Conmt. Petition (C) No.425-426/2015 in Writ Petition (C) 523/2002 dated 18.02.2025 and in supersession of this Department's previous Notifications issued in this regard, hereby notify the following Rules:

1. These Rules may be called the "Retired Chief Justices and Judges Domestic Help(s) and Other Benefits Rules, 2025".

2. These Rules shall come into force with immediate effect.

#### 3. APPLICABILITY:

These Rules shall apply to a person who has held office either as a Chief Justice or as a Judge of the High Court of Tripura and after them to their spouses.

#### 4. DEFINITIONS:

- (i) "High Court" means the High Court of Tripura.
- (ii) "Former Chief Justice" means a person who has held Office of the Chief Justice of the High Court and/or drawing pension and other benefits from the High Court and
- (iii) "Former Judges" means a person who has held Office of a Judge of the High Court and/or drawing pension and other benefits from the High Court.
- (iv) "Spouse" means the wife or, as the case may be, the husband surviving a former Chief Justice or former Judge upon his or her death while in Office or after retirement
- (v) "Domestic Help" means the assistance of personnel to be provided to a retired Chief Justice or a retired Judge of the High Court, or to his or her spouse at the expenses to be borne by the High Court.

#### 5. ELIGIBILITY:

A retired Chief Justice or a Judge of the High Court or their Spouse, as the case may be, shall be entitled to avail the services of Domestic Help(s), Driver(s), Secretarial Assistance, Security and Telephone facilities at the expenses of the High Court, subject to the following conditions.

- (i) The facility of Domestic Help(s), Driver(s), Secretarial Assistance, Security and Telephone facility shall be provided to the retired Chief Justice/Judge or their spouse, if he/she is not availing such or similar facility from any other High Court.
- (ii) The retired Chief Justice/Judge or their spouse, as the case may be, on his/her appointment to any Office, post or assignment shall not be entitled to the facility of Domestic Help(s), Driver(s), Secretarial Service and other benefits during the tenure of such appointment/assignment except where such appointment/assignment does not provide the facility of any Domestic Help(s), Driver(s) and Secretarial Service and benefits, respectively.

#### 6. SELECTION OF DOMESTIC HELP(S):

The retired Chief Justice/Judge or their spouse, as the case may be, may at her or his discretion select persons to be engaged as Domestic Help(s)/Driver(s).

#### 7. REIMBURSEMENT:

To enable the retired Chief Justice/Judge or their spouse, as the case may be, to engage domestic help(s) /Driver(s), a consolidated amount of Rs. 50,000/- per month to a retired Chief Justice or his/her spouse and Rs. 45,000/- per month to a retired Judge or his/her spouse, shall be paid.



# 8. SECONDMENT OF PERMANENT EMPLOYEES:

The retired Chief Justice/Judge or their spouse may (instead of availing of benefit as stated in para-7 above) request to avail the services of maximum of two employees working in Last Grade Service of the High Court, one of whom may be a Driver;

#### OR

If any employee working in last Grade Service of the High Court furnishes to the Registrar General of the High Court, a request in writing to serve a retired Chief Justice Judge or their spouse, as the case may be, and the services of such employee(s) Justice Judge or their spouse, as the case may be; is are acceptable to the retired Chief Justice/Judge or their spouse, as the case may be;

They may be seconded to work with the retired Chief Justice/Judge or their spouse until the employee(s) attain(s) the age of superannuation and/or so long as the retired Chief Justice Judge or their spouse is entitled to this facility.

It is made clear that if employees of the High Court are seconded, the retired Chief Justice Judge or their spouse, as the case may be, are not entitled to-full reimbursement as stipulated in Rule-7 if two employees are provided by the High Court, or 50% of the reimbursement mentioned in Rule-7 if only one employee of the High Court is provided.

The said secondment shall be at the discretion of the Hon'ble Chief Justice of the High Court and subject to availability of staff.

# 9. <u>CELL PHONE/LANDLINE EXPENSES/INTERNET CHARGES, SECRETARIAL SERVICES AND SECURITY SERVICES:</u>

The retired Chief Justice /Judge or their spouse, as the case may be, shall also be paid Rs. 15,000/- per month towards expenses of rental and calls of Mobiles and/or Landline, internet service, secretarial services and security service. However, the facility shall not be available if the retired Chief Justice/Judge or their spouse, as the case may be, shall not be available if the retired Chief Justice/Judge or their spouse, as the case may be, shall not be available if the retired Chief Justice/Judge or their spouse, as the case may be, shall also be paid to the same facilities under that assignment, during the continuation of such assignment.

- 10. The amounts mentioned in Rule-7 & 9 shall be increased by 5% every one year.
- Pension Disbursing Officers shall draw and pay the sanctioned amount of Rs. 50,000/-(Rupees fifty thousand) only and Rs.45,000/- (Rupees forty-five thousand) only per month to a retired Chief Justice or his/her spouse and to a retired Judge or his/her spouse respectively as referred to in para-7 above along with his/her pension or family pension. They also allow a lump-sum amount of Rs.15,000/-(Rupees fifteen thousand) only per month to a Retired Chief Justice or a Judge of the High Court of Tripura as reimbursement of landline telephone/mobile phone bill, internet service, Secretarial Services and Security Service as referred to in para-9 above along with his/her pension or family pension.
- 12. These Rules shall be in addition to and not in derogation of any other benefits, which may be made available to retired Chief Justice(s) /Judge(s) and /or their spouse(s), under any other arrangement/provisions.

13. This order issues with the concurrence of the Finance Department, Government of Tripura vide their U.O.No. 02 Fin(Est-II)/2025 dated 01.04.2025 and also approval of the State Government vide U.O.No.95-CS/2025 dated 03.04.2025.

#### **ORDER**

Sub: Grant of Dearness Relief to State Government Pensioners.

The Governor is pleased to order that the existing rate of Dearness Relief sanctioned vide Finance Department Order of even number dated 24-10-2024 to the State Government Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extraordinary pension etc. shall be revised from 53% to 55% with effect from 01-01-2025.

For the purpose of this order -

- (i) Pension/Family Pension in the case of pre-01-01-2016 retirees and where Family Pension was sanctioned prior to 01-01-2016, means the Revised Pension or Revised Family Pension, as the case may be, effective from 01-01-2016 in terms of Finance Department Memorandum No. F.12(6)FD(Rules)/ 2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017 and F.12(6)FD(Rules)/ 2017 Pt.-I dated 06-06-2018.
- (ii) In the case of pensioners who retire from service on or after 01-01-2017 or where family pension is sanctioned for the first time on or after 01-01-2017, Pension/Family Pension means the Basic Pension/Basic Family Pension, as the case may be, in terms of Finance Department Notification No. F.12(6)FD(Rules)/ 2017 dated 30-10-2017 as amended vide Order No. F.12(6)FD(Rules)/ 2017 dated 09-12-2017.
- (iii) Dearness Relief will also be admissible on the additional quantum of pension / family pension allowed to the pensioners who have attained the age of 80 years and above.
- (iv) Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- (v) Other provisions governing grant of dearness relief to pensioners' such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.
- (vi) This order shall also be applicable in case of Pensioners/Family Pensioners who are in receipt of provisional pension.

- (vii) This order shall not be applicable in case of Old Age Pensions, Political Pensions or any other kind of similar pensions, which are not related to the service rendered under Government.
- (viii) Dearness Relief at revised rates as above would also be admissible to pensioners who retired/retire from service of Panchayat Samiti or Zila Parishad and whose Pension Payment Orders have been issued by the Director, Local Fund Audit Department or Director, Pension and Pensioners' Welfare Department, Rajasthan, Jaipur.
- (ix) Cash payment shall be admissible from 01-01-2025.

Subject:- Grant of dearness relief on pension/family pension to the pensioners/ family pensioners(teaching & non-teaching ) of State Aided Non Govt. Colleges w.e.f. 01/04/2025.

In continuation to this office circular No. Pen.Co-ordn./51/Vol-VIII/204/Vol-II/62 dated 08/07/2024, it is stated that the Govt. of West Bengal, Higher Education Department, University Branch, in their letter No.404(31)-Edn(U)HED-12012(21)/1/2024-UNV SEC-Dept. of HE Dated 28.03.2025, has communicated that following the provision prescribed in the Government of West Bengal, Finance Department (Audit branch) Memo No.1132-F(P2) dated 25/03/2025 the pensioners/family pensioners of the teaching and non-teaching staff of the State-Aided Non-Government Colleges in this State have been allowed to draw dearness relief @ 18% with effect from 01/04/2025 on the basic pension/family pension under ROPA 2019.

Besides, the pensioners/family pensioners arising out of teaching/nonteaching employees of State aided Non-Govt. Colleges, who are still drawing pre-revised pension/family pension as per ROPA2009, will get Dearness Relief @171% with effect from 01/04/2025 till their pension/family pension is revised.

All concerned Pension Disbursing Officers are, therefore, requested to allow dearness relief on revised rates of pension/family pension @ 18% and on un-revised rates of pension/family pension @171% with effect from 01/04/2025 to the above categories of pensioners/family pensioners.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the nearest rupee in each case.

Other provisions governing grant of dearness relief to the pensioners/family pensioners not mentioned in this order, such as regulation of relief during re-employment, regulation of relief where more than one pension is drawn etc., will remain unchanged.

Accountants General/Pr. Accountants General of other States are requested to arrange additional copies of the said Govt. order at their end, if necessary, for circulation within their State.



Sub:- Sanction of Dearness Relief (T.I) @ 2% enhancing the existing rate from 53% to 55% in favour of the State Government pensioners/family pensioners with effect from 01.01.2025.

Government of India have released an additional instalment of Dearness Allowance to the Central Government Servants and Dearness Relief to the Central Government pensioners/ family pensioners increasing @ 2% over the existing rate of 53% to 55% of the basic pay/ pension with effect from 01.01.2025 as per the Union Cabinet decision on 28.03.2025.

- 2. In the meantime, one dose of Dearness Allowance @2% has been sanctioned in favour of the State Government employees enhancing Dearness Allowance from 53% to 55% with effect from 01.01.2025 vide Finance Department Office Memorandum No.11721 /F, dated 11.04.2025
- 3. After careful consideration of the matter, State Government have been pleased to decide that Dearness Relief (T.I) shall be paid to the State Government pensioners/ family pensioners at an increased rate of 2% on the revised basic pension/ family pension and provisional pension enhancing from 53% to 55% with effect from 01.01.2025.
- 4. The additional dose of Dearness Relief shall also be admissible on additional basic pension/ additional family pension available to the old pensioners/ family pensioners based on their age as indicated in this Department O.M. N0.28300/F dated 23.09.2017.

For the purpose of this Office Memorandum

- i. Pension/ family pension in the case of the pre-01.01.2016 retirees and where family pension was due prior to 01.01.2016 means the revised basic pension/ revised basic family pension as the case may be in terms of Finance Department Office Memorandum No.28300/F dated 23.09.2017.
- ii. Also, in the case of pensioners who have retired after 01.01.2016 or where family pension is sanctioned for the first time after 01.01.2016 the pension/family pension means the basic pension / basic family pension, as the case may be sanctioned on retirement/death.

- 5. The additional dose of Dearness relief shall also be admissible to the pensioners/ family pensioners of Non-Government Aided Educational Institutions including Primary Schools under School and Mass Education Department and Non-Government Aided Educational Institutions under Higher Education Department.
- 6. Payment of Dearness Relief (T.I) involving fraction of a rupee shall be rounded off to the next higher rupee.

7. Other provisions governing grant of Dearness Relief (TI) to Pensioners such as regulation of Dearness Relief during employment/ re-employment and regulation of Dearness Relief where more than one pension is drawn will remain unchanged.
