1. The paper-wise action plan for pre-examination training is summarised below:



2. The pre-examination training for CPD examination will be conducted **online only**.
3. Participation in the training is **voluntary**.
4. The training is being conducted for both the examination 1 & 2 of **2024**.
5. The training is provided **only once** for each stage of CPD examination i.e. once for CPD 1, once for CPD 2 and once for CPD 3 examination in the career of an officer.
6. All Sr. AOs, Sr. DAOs, AAOs and DAOs Gr-I meeting eligibility criteria as of

01.09.2024 i.e. completion of four years of regular service as AAO/DAO Gr-I are eligible for this training.

7. Candidates are eligible for CPD-II after 4 years of passing CPD-I and for CPD-III after 3 years of passing CPD-II.

All willing eligible Sr. AOs, Sr. DAOs, AAOs and DAOs Gr-I who meet eligibility criteria as of 01 September 2024 are to submit their applications by 30.05.2024 to Admn-I section. Application form is enclosed with this office order.


