OFFICE MEMORANDUM

Subject: Regarding grant of pension allowance @ 5%, 10% & 15% on revised basic pension/ basic family pension.

The undersigned is directed to say that vide this department's Office Memorandum No. Fin(Pen)A(3)-1/09 dated 23<sup>rd</sup> April, 2014, pension allowance @ 5%, 10% & 15% was granted on basic pension/ family pension to the State Government pensioners/ family pensioners, including AIS pensioners/ family pensioners, on attaining the age of 65 years 70 years and 75 years, respectively. Further, vide Office Memoranda No. Fin(Pen)A(3)-1/09 dated 17<sup>th</sup> September, 2016 and No. Fin(Pen)A(3)-1/2021 dated 25<sup>th</sup> February, 2022, pension allowance was ordered to be paid to the AIS pensioners and State Government pensioners respectively, on pre-revised basic pension/ family pension, in the wake of revision of pension & family pension w.e.f. 01.01.2016.

The Governor, Himachal Pradesh is now pleased to decide that Pension Allowance @ 5%, 10% and 15% will be paid with effect from 1<sup>st</sup> October 2022, on attaining the age of 65 years, 70 years and 75 years respectively on revised pension/ family pension to the Government pensioners/ family pensioners.

These orders will also apply to the All India Services Pensioners/ family pensioners of Himachal Pradesh Cadre.

These instructions may be strictly adhered to by all the Government Departments and Pension Disbursing Authorities. All the Pension Disbursing Authorities (PDA's) are requested to take necessary action, accordingly.

Other terms and conditions for grant of Pension Allowance will remain same.



The undersigned is directed to refer Office Memorandum No. 1/3(1)/2008-E-II (B) dated the 12<sup>th</sup> October, 2022 of the Ministry of Finance, Department of Expenditure, Government of India regarding payment of Dearness Allowances (DA) to the employees of Central Government and Central Autonomous Bodies who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission w.e.f. 01.07.2022 and to inform that enhanced rate of DA from the existing rate of 205% to 212% of Basic Pay w.e.f. 01.07.2022 will be applicable for the employees of Central Government and Central Autonomous Bodies who have been continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission. This is also applicable for Tripura Judicial Service Officers and those retired from Tripura Judicial Service, whose basic pay/pension has not been revised in terms of Law Department's Memorandum No. F.1(1)SECY/1A/W/MISC/2019/145-58, dated 30.09.2022.
