Sub: PwBD candidates passed under relaxed standards in SAS Examination held from 30.06.2016 to 16.05.2022- Grant of notional promotion as AAO to Shri.Joyal Manuel and Ms.Laina CN – reg.

HQ Office vide letter No. 269/07-Exam/court case/2024 dated 06.08.2025 has declared the result of PwBDs candidates who have passed/exempted in various papers, under relaxation upto 5% applicable to PwBDs candidates in SAS Examinations conducted during the period from 30.06.2016 to 16.05.2022.

Based on the above, Shri Joyal Manuel, Assistant Audit Officer (Category- PwBD-b), is treated to have passed the Supplementary Examination of 2020 under relaxed standards in lieu of SAS Examination-II of 2022, and Ms. Laina CN, Senior Auditor (Category- PwBD-c), is treated to have passed SAS Examination-I of 2023 under relaxed standards.

Consequently, **notional promotion** to the cadre of **Assistant Audit Officer in Level- 8 of the Pay Matrix** is granted to **Shri Joyal Manuel** with effect from **10.05.2022 (Main Panel of 2022)**, with monetary benefits w.e.f. 19.04.2023, the date on which he assumed charge as AAO and to **Ms. Laina CN** with effect from **26.12.2023 (2nd Supplementary Panel of 2023)** with monetary benefits from the date of assumption of charge.

Accordingly, Shri.Joyal Manuel will be placed below Ms.Simisha CM and above Shri. Pallav Majumdar and Ms.Laina CN will be placed below Ms.Lekshmi IN and above Shri. Rohith N, in the seniority list of Assistant Audit Officers.

The above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in SLP(C) No.31288/2017.
