As per GOI, O.M. No.35034/3/2008-Estt (D) dated 19.05.2009 read with OM.No.35034/3/2008-Estt.(D) (Vol.II) dated 01.11.2010 and 04.10.2012 and GOI O.M. No.35034/3/2015-Estt.(D) dated 22-10-2019, it has been decided to grant three financial upgradations under MACP Scheme, counted from the direct entry grade on completion of 10, 20 and 30 years service respectively, to all regularly appointed Group 'A', 'B' and 'C' Central Government Civilian Employees except officers of the Organized Group 'A' Service. Financial upgradation under the scheme will be admissible whenever a person has spent 10 years continuously in the same grade pay/pay level.

On grant of financial upgradation under the Scheme, there shall be no change in the designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Government accommodation shall be permitted.

The financial upgradation under MACP Scheme shall be purely personal to the employee and shall have no relevance to his/her seniority position. As such there shall be no additional financial upgradation for the senior employee on the ground that the junior employee in the grade has got higher pay /grade pay under the MACP Scheme.

Fixation of pay on grant of financial upgradation under MACP Scheme shall be made as per Rule 13 of CCS (RP) Rules, 2016 issued vide Department of Expenditure notification dated 25th July, 2016 and in terms of provisions contained in DoP&T O.M. No.13/02/2017-Estt.(Pay-I) dated 27-07-2017.

The benefit of pay fixation available at the time of promotion shall also be allowed at the time of financial upgradation under the MACP Scheme.

The following officials are granted the benefit of 3rd financial upgradation under MACP Scheme with effect from the date noted against them and their pay is upgraded to the Pay Level in the Pay Matrix noted against each of them.
