ABSTRACT

ALLOWANCES - Rate of Dearness Allowance applicable with effect from 01-04-2023 in respect of employees continuing to draw their pay in the Pre - 2016 pay scale/Grade Pay - Orders - Issued.

ORDER:

In the Government Order read above, orders were issued sanctioning revised rate of Dearness Allowance to the State Government employees drawing pay in the Pre-revised pay scales as detailed below:-

Pre-2016 pay scale/Grade Pay	
Date from which payable	Rate of Dearness Allowance [per month]

01-01-2023	212% of Pay plus Grade Pay

2. The Government now sanction the enhanced rate of Dearness Allowance to the State Government employees drawing pay in the Pre-revised scales of pay/Grade pay as detailed below:-

Pre-2016 pay scale/Grade Pay	
Date from which payable	Rate of Dearness Allowance [per month]
01-04-2023	221% of Pay plus Grade Pay

3. The rate of Dearness Allowance payable under these orders shall be paid in cash with effect from 01-04-2023. Dearness Allowance for the period from 01-01-2023 to 31-03-2023 Pre - 2016 pay scale/Grade Pay shall be paid at the rates of 212% continuously.

4. The Payment of Dearness Allowance from the month of April 2023 shall be drawn and disbursed by existing cashless mode of Electronic Clearance System (ECS). While working out the revised P.T.O.

Dearness Allowance, fraction of a rupee shall be rounded off to next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

- 5. The expenditure shall be debited to the detailed head of account "303. Dearness Allowance" under the relevant minor, submajor and major heads of account.
- 6. The Treasury Officers / Pay and Accounts Officers are requested to make payment of the revised Dearness Allowance when bills are presented without waiting for the authorisation from the Principal Accountant General (A&E) Tamil Nadu, Chennai-18.
