No. 1/3(1)/2008-E.II(B) dated 12th October, 2022 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies, who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6th Central Pay Commission, shall be enhanced from the existing rate of 212% to 221% of Basic Pay w.e.f. 01.01.2023.

- 2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(3)/2008-E.II(B) dated 29th August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.
