The undersigned is directed to enclose herewith a copy of the Office Memorandum issued from GOI, Ministry of Finance, Department of Expenditure Vide No.1/3(1)/2008-E.II(B) dated the 7th April, 2022 regarding rate of enhancement of DA to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/ grade pay as per 6th Central Pay Commission w.e.f. 01.01.2022.

All Heads of Departments/ Head of Offices are, therefore, requested to arrange payment of DA as per the above enhanced rates of DA i.e. from 196% to 203% of Basic Pay w.e.f. 01.01.2022 to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/ grade pay as per 6th Central Pay Commission.

This enhanced rate of DA is applicable as DA/DR on their pre-revised Pay/Pension from the same date and on the same terms and conditions in respect of serving members of Tripura Judicial Service and those retired from Tripura Judicial Service also.

This is in partial modification of earlier Memo No. No.F.5(6)-FIN(G)/79(Part-II)/10 dated 19th April 2022.

MEMORANDUM

Subject: Release of further installment of Dearness Relief.

The undersigned is directed to refer to the subject mentioned above and to state that the Governor of Tripura is pleased to decide grant of further installment of Dearness Relief @ 5% over the basic pension/ basic family pension as admissible under Tripura State Civil Services (Revised Pension) Rules, 2017 read with its 1st Amendment, 2018 with effect from 01-07-2022, to the State Government pensioners and family pensioners. With the release of this installment, total quantum of Dearness Relief payable to the State Government pensioners and family pensioners with effect from 01-07-2022 shall stand at 8% (3%+5%) over the Basic pension/ family pension, as the case may be. The arrears of enhanced 5% Dearness Relief for the month of July, 2022 may be paid along with the pension amount of August, 2022.

- 2. The payment on account of Dearness Relief involving fractions of 50 paisa and above may be rounded to the next higher rupee and the fractions of less than 50 paisa may be ignored.
- 3. The Pension Disbursing Authorities including Public Sector Banks handling disbursement of pension/ family pension to the State Government Pensioners / Family Pensioners are authorized to calculate and disburse Dearness Relief at the above rate and manner in each individual case from **01-07-2022**.
- 4. The expenditure on payment of Dearness Relief on pension/ family pension to the State Government Pensioners / Family Pensioners respectively shall be debitable to the Major Head '2071-Pension and other Retirement Benefits'.
