## OFFICE MEMORANDUM

Sub: Allowing revised pension/family pension and other retirement benefits and payment of corresponding arrear to the retired Judicial Officers of the state from 01.01.2016, as per the recommendation of the Hon'ble Second National Judicial Pay Commission (relative to Seventh Pay Commission).

- 1. In compliance with the orders passed on 19.05.2023 by the Hon'ble Supreme Court, New Delhi in WP(C) No. 643/2015 All India Judges Association Vs Union of India and others, orders have been issued for allowing revised pension/family pension and other retirement benefits and payment of corresponding arrear to the retired Judicial Officers of the state from 01.01.2016.
- Hence, in view of the above, in compliance with the orders passed on 19.05.2023 2 by the Hon'ble Supreme Court, in Writ Petition No. 643/2015 All India Judges Association Vs Union of India and others, "revised pension/family pension and other retirement benefits to be allowed and payment of corresponding arrear to be made to the retired Judicial Officers of the state from 01.01.2016, as per the recommendation of the Hon'ble Second National Judicial Pay Commission".

#### Pension/ Family Pension i.

- (A)50% and 30% of basic pay has been fixed as pension and family pension respectively to the Judicial Officers retired on or after 01.01.2016.
- (B) The revision of pension/family pension of the Judicial Officers retired/ deceased after 09.11.2000 and before 01.01.2016 shall be done as per the following two formulas.
- a) First Formula: The pension/family pension will be fixed by multiplying the amount of pension/family pension received as on 31.12.2015 by a constant
- b) Second Formula: The pension (50% of Basic Pay) and family pension (30% of Basic Pay) payable as on 01.01.2016 will be fixed by notionally fixing the basic pay in substitute pay scale/pay band and grade pay received in their pay scale/pay band and grade pay on the date of retirement/death of the concerned Judicial Officer, in the light of the recommendations of subsequent pay committees. Out of the above two formulas, the one which is more beneficial will be admissible as revised pension/family pension.

#### Death-Cum-Retirement Gratuity: ii.

- (a) The maximum limit of Death Cum Retirement Gratuity will be Rs 20 lakh. This maximum limit will increase by 25% when Dearness Allowance reaches .
- (b) Death gratuity.

Period of Service	Amount of Death Gratuity
Less than I year	2 (two) times the emoluments
More than 01 year but less than 5 years	6 (six) times the emoluments
More than 05 years but less than 11 years	12 (twelve) times the emoluments
More than 11 years but less than 20 years	20 (twenty) times the emoluments
20 years or more	Half of the emoluments for each completed half year of pensionable service, which shall not be more than 33 times of the emoluments. In case of death on or after 01.01.2016, the maximum limit will be Rs.20 lakh.

#### iii. Amount of Additional Pension:

The provision of additional pension for the judicial service pensioners/family pensioners will be implemented from 01.01.2016, as under:

SL No.	Age of pensioner/family pensioner	Amount of additional Pension
1.	More than 75 years and less than 80 years	20% revised basic pension/family pension
2.	More than 80 years and less than 85 years	30% revised basic pension/family pension
3.	More than 85 years and less than 90 years	40% revised basic pension/family pension
4.	More than 90 years and less than 95 years	60% revised basic pension/family pension
5.	More than 95 years and less than 100 years	80% revised basic pension/family pension
6.	100 years and more	100% revised basic pension/family pension

If any additional pension has been paid to the retired Judicial Officers (70 to 75 years), as per the earlier provisions, it will not be recovered.

#### iv. Miscellaneous:

- (a) For the admissibility of family pension, the income of dependent family members should be less than Rs.30,000/- (Rupees Thirty Thousand only) per month.
- (b) In case of death during the period of service, family pension (50% of basic pay) at the increased rate will be admissible for the next 10 years from the date of death. In case of death after retirement, family pension (50% of basic pay) at the increased rate will be admissible for 07 years from the date of death or till the date on which the government servant would have attained the age of 67 years, if he were alive, whichever is earlier.
- (c) The benefits of number of years of practice at bar subject to maximum of weightage of ten years will be given to direct recruits of HJS who retired prior to 01.01.2016.
- v. The above provisions will be effective from 01.01.2016 and payment will be made from 01.07.2023. The payment of arrear amount consequent to revision of pension (from 01.01.2016 to 30.06.2023) will be made as follows:
  - (a) Payment of 25% of the total arrear amount will be made by 31.08.2023.
  - (b) Payment of 25% of the total arrear amount will be made by 31.10.2023.
  - (c) Payment of 50% of the total arrear amount will be made by 31.12.2023.
- The provisions applicable in respect of pension/terminal benefits shall stand amended to this extent.
