SUBJECT: Grant of ex-gratia payment for the year 2024-2025 payable to the pensioner/family pensioners of the teaching and non teaching employees of Non-Govt. Educational Institution governed by DCRB' 81 scheme.

It is informed that the Govt. of West Bengal, Higher Education Department, Budget Branch in their Memo No. 20-HED-13014(99)/3/2025-BDG SEC dated 25.03.2025 readwith School Education Department Memo No.130-SED-18030/1/2018-PB SEC-Dept. of SE Dated 19.03.2025 have sanctioned Ex-gratia grant of Rs. 3,500/- (Rupees three thousand five hundred) only in lump per head to all pensioners/family pensioners of the teaching and non teaching employees of Non Govt. Educational Institution guided under DCRB' 81 scheme (excluding DA Getting Schools and Sanskrit Tolls) including the holders of provisional pension who retired/died prior to 30.09.2024 and also the pensioners/family pensioners who retired or died after 30.09.2024 but prior to 01.09.2025 and are not eligible to receive ad-hoc bonus.

- The above categories of pensioners/family pensioners whose basic pension/family pension plus relief on pension as on March 31, 2025 did not exceed Rs.38,000/-(Rupees thirty eight thousand) only are entitled to get this benefit.
