Training in the Fourth quarter of 2024-25

In the fourth quarter of 2024-25, RCB&KI conducted 09 General Courses and 04 EDP courses (Annex A). These courses received average grading of 9.08 and 9.00 respectively out of 10.0. A total of 185 participants attended General courses while 117 participants participated in the EDP courses.



संसदीय राजभाषा समिति


