INDUCTION TRAINING FOR NEWLY RECRUITED DIRECT AAOS

The Induction Training for Direct Assistant Audit Officers (Railways) (CGLE-2022) - Phase 1 was conducted online from July 4 to August 23, 2024, comprising 140 sessions. The training covered essential topics, including the overview of the IA&AD organization, applicable rules and regulations, principles of Railway Audit, auditing methodology, and skills in personality development, communication, stress and time management, and teamwork. Participants engaged in both individual and group presentations, enhancing the learning experience. Faculty from across India delivered the training, which received positive feedback for its informative content.



# ALL INDIA TRAINING PROGRAM ON SERVICE DELIVERY ORIENTED AUDIT

A special five-day All-India training program on "Service Delivery Oriented Audit: What This New Paradigm Means and How to Apply It in Audit" was organized within the context of Local Governance Audít from September 2 to September 6, 2024. The program was inaugurated by Ms. Yashodhara Ray Chaudhurí, Addítional Deputy Comptroller and Audítor General of Local Governance. She emphasized the importance and implementation of 'Service Delivery Oriented Audit' in local bodies. Esteemed faculty members covered various topics, including the role of Urban Local Bodies (ULBs) and Panchayati Raj Institutions (PRIs) in service delivery, devolution status, a function-based district-centric audit approach, techniques for service delivery audit planning, data collection and analysis, reporting, and the impact of service delivery audits. The course concluded with insights on the way forward, presented by Ms. Reena Saha, Director General of Local Governance. A course rating of 9.69 indicates that participants found the training highly beneficial.

## AITP ON AUDITING THROUGH REMOTE SENSING AND GIS

The Geographical Information System (GIS) is a computer-based tool that supports the collection, maintenance, storage, analysis, output, and distribution of spatial data and information. In the evolving landscape of audit methodology, GIS and Remote Sensing have become essential tools in the auditor's repertoire. To enhance audit techniques, an All-India Training Program on Auditing through Remote Sensing and GIS was organized at the Regional Remote Sensing Centre (East), NRSC, ISRO Kolkata.

The training covered key topics such as the Indian Space Programme and emerging challenges, digital image processing (DIP) and classification, concepts of remote sensing, fundamentals of GIS, map projections and geometric corrections, fundamentals of GPS, and the application of GIS technology in auditing. The sessions were led by expert scientists and engineers from NRSC, ISRO Kolkata, along with Ms. Hemalatha Ravishankar, Deputy Director, Office of the Director General of Audit (Central), Kolkata. The program received an impressive rating of 9.15 from the participants.

# STM/Case Studies/Research Paper and Other Allied Activities.

The case studies on "Audit of PRIs relating to the implementation of Sustainable Development Goals (SDGs)" and "Fraudulent Payment of Legal Fees" were approved and uploaded on the SAI Training portal for training purposes in August 2024 and September 2024, respectively. Furthermore, RCBKI, Kolkata, was assigned to review the session-wise and incorporate changes (additions, deletions, presentations modifications) in the Railway Audit Sessions included in the Mandatory Training for AAOs to be empanelled for promotion as SAOs from the panel year 2024. 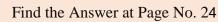
