## Implementation of COTP 2021-22

The first quarter of 2021-22 was a difficult time for the RTI. Fifty percent of regular staff, including faculty was afflicted with Covid-19. Despite difficulties the RTI successfully conducted all planned courses without curtailment of any session.

## Trainings in the First quarter of 2021-22

In the first quarter of 2021-22, RTI conducted, 06 General Courses and 01 EDP course (Annex A) including Induction Training (Phase-I) for newly recruited AAOs. These courses received average grading of 4.50 and 4.77 respectively. Total 176 participants from 19 user offices attended General courses while 24 participants from 13 offices participated in the EDP course.

The training sessions were handled by core faculty of the Institute, Group officers of IA&AD, serving / retired Senior Audit Officers and external experts (Annex B)

## *Induction training to newly recruited AAOs*

Online induction training course (phase-I) was organized for newly recruited Assistant Audit Officers between 01 April 2021 and 07 May 2021; 46 AAOs from 06 user offices DGA, Central Receipt; PDA, Infrastructure; PDA, Health, Education and Skill Development; Pr.AG (Audit); PDA, Environment and Scientific Departments; and PDA, Industry and Corporate Affairs participated in the online training programme.

Participants were divided into three groups mentored by the Sr. AOs in the core faculty of the RTI. These groups served to provide personalized attention to participants, compensating the lack of physical face to face interactions with instructors.

The focus of this training was to assist the AAOs on probation to write the SAS examination. Soft copies of training materials, reading materials and practice questions for SAS examination used for the training can be accessed on the RTI Jaipur website under the tab course material-SAS probationer Phase-I training.
