## Training in the Third quarter of 2024-25

### All India Workshop on Performance Audit

“All India workshop on Performance Audit” was organized by the RCBKI between 11 November 2024 and 12 November 2024. 18 participants and 05 Group Officers participated in this 02 days’ workshop.

The theme of this All-India Workshop was "Using GIS in Various Performance Audits." The institute invited Ms. Sushila Yadav, Joint Director, Department of Watershed and Soil Conservation,

Government of Rajasthan and Prof. MK Jat from MNIT, Jaipur as the resource persons. The workshop also included case studies on Performance Audit of Forest Department & Mining department using GIS.

The course was highly appreciated by the participants, as reflected in the grading received, which remained 9.39 out of 10.00.



## Training on Performance Audit

The training on Performance Audit was conducted from 02<sup>nd</sup> December 2024 to 06<sup>th</sup> December 2024.

26 participants attended this 05-day training program. The course Structure was quite

engaging and informative. It included case studies, General discussion & syndicate task. The training received high acclaim from the participants, as reflected in the grading of 9.04 out of 10.



## Development of Research Paper

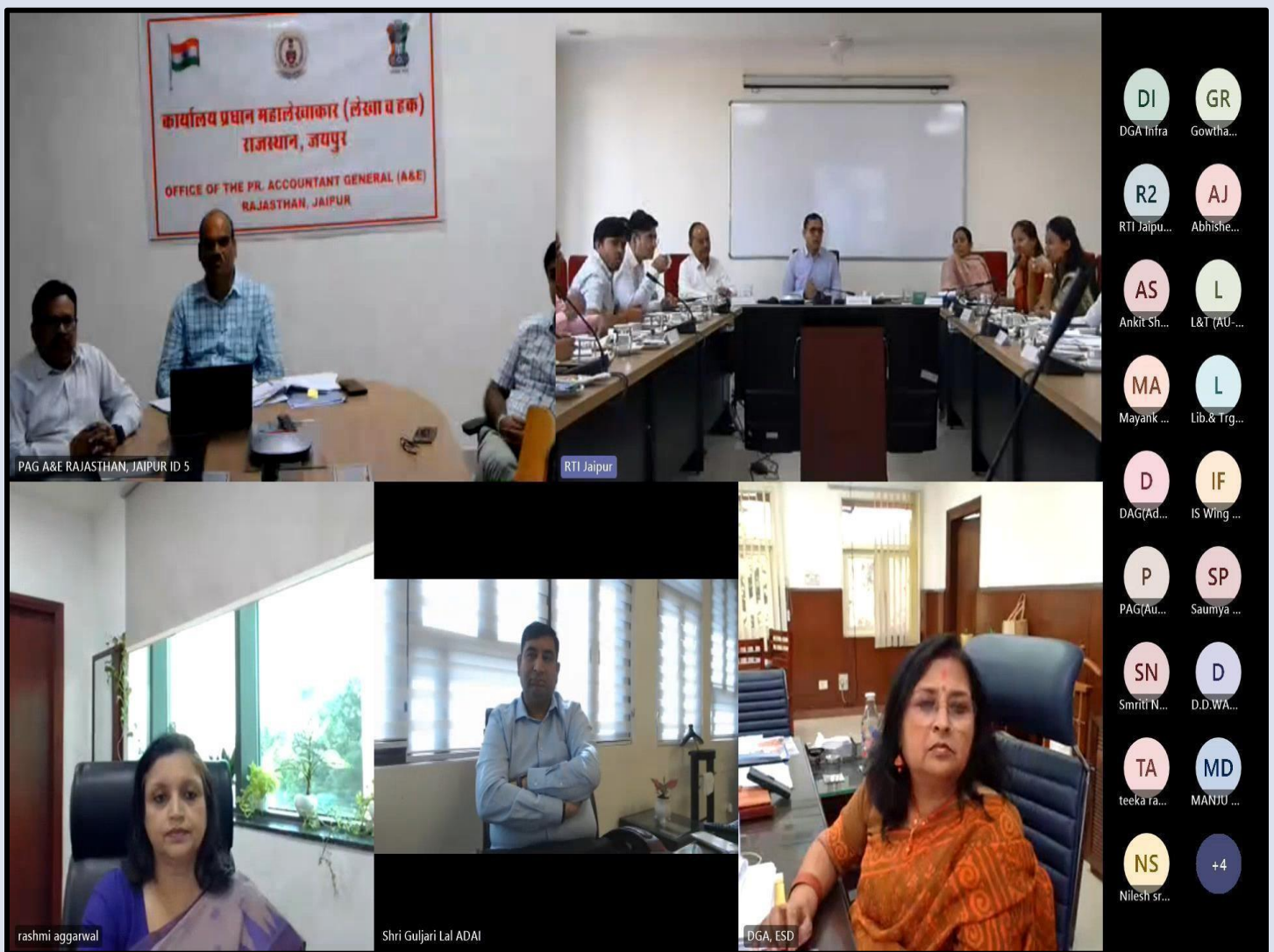
# Mid-term RAC Meeting 11 Oct. 2024
