## MID-CAREER TRAINING PROGRAMME LEVEL-3

*The Mid-Career Training Programme (MCTP), introduced in 2021 for Senior Audit Officers (SAOs) and Assistant Audit Officers (AAOs), aims to strengthen professionalism, impartiality, and efficiency within the Department. During this quarter, the Institute organised two batches of MCTP Level-3 in July and August 2025.*

*The programmes focused on developing essential competencies, covering a wide spectrum of subjects such as stakeholder communication, internal controls, analytical thinking, fraud detection, e-governance attributes, risk management, compliance frameworks, team-building, stress management, ethics, IT audit techniques, and global environmental challenges.*

*To enhance experiential learning, participants of Level-3 (July 2025) visited Metcalfe Hall, Kolkata, while those of Level-3 (August 2025) visited the National Library, Kolkata. Participants demonstrated active involvement in all sessions and activities, which greatly enriched the training experience.*

*Both programmes received an excellent response, with average feedback scores of 9.10 for the July batch and 9.80 for the August batch, reflecting their overall effectiveness.*

**ADMINISTRATIVE AND ESTABLISHMENT  
MATTERS ALONGWITH OFFICE PROCEDURE,  
LEGAL MATTERS AND DISCIPLINARY  
PROCEEDINGS**

*The training programme on Administrative and Establishment Matters along with Office Procedure, Legal Matters and Disciplinary Proceedings, conducted from 15-19 September 2025, received an excellent course rating of 9.50. The programme covered a comprehensive range of topics essential for effective office administration and good governance, including ethics and values, recruitment rules, preparation of gradation lists, and key provisions of the CCS (Conduct) Rules and CCS (CCA) Rules, 1965. Participants also gained insights into the Right to Information Act, budgeting processes (BE and RE), AC/DC bills, DDO functions, and legal matters relevant to IA&AD. Sessions further addressed APAR management, the PoSH Act, OPS, NPS and UPS frameworks, as well as TA/LTC rules and e-HRMS, equipping participants with updated knowledge for efficient and compliant administrative functioning.*

## ORIENTATION TRAINING FOR SUPERVISORS AND DRAAOS/DPAAOS

*This Institute conducted an extensive Orientation Training Program for user offices from 30 June to 08 August 2025. The program offered a structured introduction to the Department's functioning, familiarising participants with key rules, regulations, and core audit procedures, along with essential skills in noting and drafting.*

*Participants received practical exposure to several IT applications used in daily operations, including OIOS, e-HRMS, e-Office, IDEA, and Tableau, in addition to foundational IT audit techniques. The curriculum also placed strong emphasis on personality development and communication skills to enhance professional engagements with auditee organisations.*

*The training covered a wide spectrum of subjects, such as enthusiasm and organisational culture, tax-related concepts, advanced MS Excel features, Hindi Rajbhasha, CAAT, transparency and governance, creative problem-solving, delegation of financial powers, constitutional provisions pertaining to budgeting, adherence to the Code of Ethics within the CAG's office, opportunities for career growth, and gender sensitisation.*

*A distinguished panel of esteemed faculty members from across India, local experts, and internal faculty conducted the sessions, enriching the programme with their diverse knowledge and experience.*

*Participants showcased their presentation abilities through individual and group assignments. As part of experiential learning, they visited the Anthropological Survey of India, Eastern Regional Centre, Kolkata, where they were guided by the officials during an insightful field visit.*

*The programme was highly appreciated by attendees and received an excellent overall rating of 9.55.*

## ALL INDIA TRAINING PROGRAM ON AUDITING THROUGH GIS TECHNOLOGY

The Geographical Information System (GIS) is a digital tool for collecting, organizing, analyzing, and visualizing spatial data. It enables users to capture and display geographic information through layered maps and interactive visuals, helping uncover patterns that support better decision-making. In public audit, GIS is increasingly used to examine areas like social infrastructure, environment, water resources, and land use. Standards such as ISSAI 5540 also highlight its importance, especially in audits related to disaster management and relief efforts.

In pursuance of strengthening auditors' capabilities in geospatial technologies, the Regional Capacity Building and Knowledge Institute, Kolkata organized a training programme on Auditing through Remote Sensing and GIS from 21st to 25th July 2025. This training program was held at NRSC, ISRO Branch Kolkata. The course introduced participants to key concepts including the Indian Space Programme, fundamentals of remote sensing, digital image processing, GIS basics, map projections, GPS operations, and the practical application of geospatial tools in audit work. The sessions were led by experienced scientists and engineers from NRSC and ISRO Kolkata, ensuring a rich and practical learning experience for all attendees.



## ALL INDIA TRAINING PROGRAM ON RAILWAY AUDIT

The All India Training Program on Railway Audit was conducted from 22.09.2025 to 26.09.2025, providing participants with an in-depth understanding of key financial and accounting mechanisms within the Indian Railways.

The programme covered a comprehensive range of topics, including the structure of Railway Accounts; roles and responsibilities of the Railway Accounts Department; preparation of Current Account (Revenue & Capital); formulation of various grants, statements, and accounts under Appropriation Accounts; and important aspects of re-appropriation. Sessions also addressed fund accounting such as DRF, DF, and other railway-specific funds, along with the audit of accounts, financial statements, annexures, and grants under Appropriation Accounts.

Participants further received an introduction to the Integrated Payroll and Accounting System (IPAS), covering payroll processing, salary bill preparation and passing, abstract preparation, and cash book maintenance.

The training was delivered by distinguished faculty members from the Indian Railways, a retired IA&AD officer, and internal faculty members. The programme received excellent feedback, achieving an overall rating of 9.40.

## TRAINING ON DATA ANALYTICS USING KNIME AND TABLEAU


The Institute conducted a training programme on Data Analytics using KNIME and Tableau from 18.08.2025 to 22.08.2025. Data analytics—the systematic examination of large datasets to derive meaningful insights, identify trends, and support data-driven decision-making—has become an essential component of modern auditing. Its application enables auditors to detect anomalies, evaluate risks, and enhance both the accuracy and efficiency of audit processes. The course began with an inauguration session and an introduction to database fundamentals. Over the five days, participants were exposed to a wide range of topics, including:

- Basic concepts of data analytics
- Data types such as string and numeric
- Types of analytics
- KNIME: broad overview, building basic workflows, understanding nodes, ETL operations, and statistical analysis
- Tableau: data cleaning and preparation, default and advanced chart creation, data analysis, and hands-on case studies

The sessions were delivered by a combination of external experts and internal faculty members. Participants expressed satisfaction with the course, noting that the programme successfully met its intended learning objectives.

## IT AUDIT THEORY AND PRACTICAL TRAINING

To enhance the technological proficiency of CAG auditors, the Institute conducted a comprehensive IT Audit Theory and Practical training programme from 03.09.2025 to 12.09.2025. The course aimed to build a strong foundation in understanding IT systems and their growing importance in organisational functioning, along with the critical role of IT audit in risk management.

During the programme, participants were introduced to key aspects of IT audit planning, preparation, and methodology development. The curriculum also covered the functioning of IT systems within organisations, concepts related to various Software Development Life Cycle (SDLC) models, project governance and management practices, and procedures for hardware procurement. In addition, auditors were exposed to the use of data analytics tools in evaluating the effectiveness of IT controls and systems.

The training seamlessly integrated theoretical concepts with practical exercises, offering participants valuable hands-on experience. The programme received highly positive feedback from attendees, securing an overall rating of 9.0.


## TRAINING PROGRAMME ON IDEA

The IDEA software (Interactive Data Extraction and Analysis) is an advanced analytical tool widely used for data examination, audit procedures, and investigative reviews. It supports auditors in extracting, analyzing, and validating large datasets, thereby assisting in identifying anomalies, enhancing audit quality, and strengthening compliance checks. Given its significance, the Institute continues to focus on upskilling departmental officers in the effective use of this software.

During the last quarter, the Institute conducted a comprehensive training programme on IDEA from 14.07.2025 to 18.07.2025. Over the course of the programme, participants were familiarised with:

- Core features and functionalities of IDEA
- Project and file management techniques
- Data validation using Field Statistics and Control features
- Methods to filter, isolate, and save specific records
- Field manipulation, creation of new fields, and application of functions
- Summarisation techniques, identification of duplicates and gaps
- Working with multiple databases, including merging and appending
- Practical case studies demonstrating real-time use of IDEA

The programme was highly appreciated by the participants, earning an excellent feedback rating of 9.70, reflecting its effectiveness and relevance to audit operations.
