Trainings in the First quarter of 2022-23

In the first quarter of 2022-23, RTI conducted, 12 General Courses and 4 EDP course (Annex A) including Induction Training (Phase-I) for newly recruited AAOs. These courses received average grading of 4.70 and 4.75 respectively out of 5.0. Total 176 participants from 19 user offices attended General courses while 55 participants from 13 offices participated in the EDP course.

Induction training to newly recruited AAOs

Induction training course (phase-I) was organized for newly recruited Assistant Audit Officers between 04 April 2022 and 05 May 2022; 24 AAOs from 04 user offices; PDA (Central), Ahmedabad, Pr.AG (Audit), Himachal Pradesh Shimla, PDA (Central) Chandigarh and Pr.AG (Audit), Gujarat, Rajkot participated in the induction training program.

The focus of this training was to assist the AAOs on probation to write the SAS examination. Training materials, reading materials and practice questions for SAS

examination used for the training were distributed to participants.

Outcome based Audit

All India Seminar on Outcome Based Audit was organized by the RTI between 01 June 2022 and 03 June 2022. 05 Group Officers and 07 Senior Audit Officers and 16 other officials participated in the 03 days' seminar. 05 senior IA&AS officers delivered lectures on the topic alongwith their experience sharing.

Mid-Career Training Programs

IA&AD introduced five levels of Mid-career Training programs (MCTP) for its officers from 2021-22 onwards.

In this context two MCTP Level 2 programs and two MCTP Level 3 programs were conducted in the first quarter of 2022-23 in which 129 participants were given training. RTI plans to conduct 04 MCTP programs in the next quarter.

Additional Training for the user offices

Additional training course of 03 days on 'Financial Audit of Central Autonomous Bodies' was conducted between 23.06.2022 and 25.06.2022 on the special requested received from Principal Director of Audit (Central), Ahmedabad (Branch office Jaipur) in which 16 officials participated. The training course was appreciated by the participants and course received grading of 4.67 out of 5.0.


