SAS / IE / CPD-I / CPD-II / CPD-III Examination-I of 2026 is scheduled to be held during from 22.06.2026 to 27.06.2026. The date sheet is as under:-

Applications are invited from eligible Officers/Officials belonging to the following categories:

I. SAS Examination (Civil)

- 1) Repeaters- Candidates who appeared in SAS Examination held in January- 2026 (Examination-2 of 2025) or earlier but could not qualify and:
 - a) have not exhausted six chances; or
 - b) have exhausted six chances but secured exemption in passed at least five papers and are eligible under the exam provisions regarding maximum attempts and time limit.
- 2) Fresh Candidates- Departmental candidates who have appeared in the SAS Preliminary Examination held on 14.05.2026, the results of which are yet to be declared. In terms of Examination Wing Circular No. 429/08-Exam/SAS etc. Exam/2026 dated 25.05.2026, the following conditions shall be applicable to SAS candidates registering for the first time (fresh candidates):
 - a) Overall passing percentage in each paper shall be 50%.
 - b) Sectional passing percentage in each paper for each section shall be 40%.
 - c) Exemption threshold for each paper shall be 60%, subject to the prescribed validity period i.e. the currency of the exemption period will be limited to 3 years.

II. Incentive Examination (Civil)

- 1) Candidates appearing for the first time IE must have completed one year of continuous service as Assistant Accounts Officer as on 01.03.2026.

III. Continuous Professional Development (CPD-I) Examination

- 1) Repeaters- Candidates who have appeared in CPD-I Exam held in January-2026 (Examination-2 of 2025) or earlier but failed to qualify.
- 2) Fresh Candidates- Candidates appearing for the first time in CPD-I must have four years of continuous service as Assistant Accounts Officer as on 01.03.2026.

IV. Continuous Professional Development (CPD-II) Examination

- 1) Repeaters- Candidates who appeared in CPD-II Examination held in January-2026 (Examination-2 of 2025) or earlier, but failed to qualify.

- 2) Fresh Candidates- All candidates after completion of four years as on 01.03.2026 from the first date of the month in which CPD-I examination was conducted and declared successful are eligible to appear for CPD-II examination.

V. Continuous Professional Development (CPD-III) Examination

- 1) Repeaters- Candidates who have appeared in CPD-III Examination held in January-2026 (Examination-2 of 2025) or earlier, but failed to qualify.
- 2) Fresh Candidates- All candidates after completion of three years as on 01.03.2026 from the first date of the month in which CPD-II examination was conducted and declared successful are eligible to appear for CPD-II examination.


Submission of Applications

Applications for SAS / IE / CPD-I / CPD-II / CPD-III Examination-I of 2026 should be submitted in the prescribed application format (ANNEXURE-I/II) to Admin Section.

Last Date

The last date for submission of applications/willingness for training is 05.06.2026.

- 1) Officials working in field offices/deputation, if any, may submit their applications through e-mail at agaejharkhand@cag.gov.in. Kindly mention the subject as "Applications for SAS / IE / CPD-I / CPD-II / CPD-III Examination-I of 2026."
- 2) Applications received after the due date shall not be entertained. Incomplete applications are liable to be rejected.
- 3) The detailed syllabus and sample model questions have been uploaded on the official website of the CAG under the examination tab.
- 4) The official who are on deputation to other offices with the department may submit their application directly to their parent offices under intimation to Administration section of the borrowing office.
- 5) In the first part, pre-registration will be done by this office on the basis of the application received from the interested candidates. The login ID & password will be received by the candidates through SMS on the mobile number given in the application. In case of non- receipt of login ID & password, please inform the Training & Exam cell section by 10.06.2026.
- 6) After receiving the login ID & password, the candidates must login through CAG website via link: - <https://agexam.in/Candidate/CandidateLogin.aspx>. The candidates must then verify the information entered by the office & complete the second part of the registration with the remaining details as required. Candidates must complete the second part of the registration by 11.06.2026.
