OFFICE ORDER

Subject: Coverage under Central Civil Services (Pension) Rules, in place of National Pension System, of those Central Government employees who were recruited against the posts/vacancies advertised /notified for recruitment, on or before 22.12.2003.

In pursuance of Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners' Welfare OM No. 57/05/2021-P&PW(B) dated 03.03.2023, (enclosed) forwarded vide Headquarter's Office Circular No. 66- Staff Entt (Rules) /A.R./ 03-2022 dated 09.03.2023, all cases where the Central Government civil employees have been appointed against a post or vacancy **which was advertised/notified prior to the date of notification for National Pension System, i.e. 22.12.2003** and are covered under the National Pension System on joining service on or after 01.01.2004, are to be given a one-time option to be covered under the CCS (Pension) Rules, 1972 (now 2021). The Government servants who exercise option to switch over to the pension scheme under CCS (Pension) Rules 1972 (now 2021), shall be required to subscribe to the General Provident Fund. The account of the corpus in the NPS account of the Government servant shall be done as per instructions contained in the OM dated 03.03.2023.

In view of above, the following instructions are issued:-

(a) Those eligible Government Servants, who are presently employed in this office and had joined posts in this office, for which such option is being exercised, and whose cases are to be considered by the Appointing Authority in this office, are instructed to submit their options in the **Annexure-A**.

(b) Those eligible Government Servants, who had joined this office after Technical Resignation from other departments/offices and are presently employed in this office, but whose cases are to be considered by the Appointing Authority in their previous offices, are instructed to submit their option in **Annexure-B**, along with valid documentary proof, so that it may be forwarded to the concerned offices.

If their past service has not been counted and regularised, request may be submitted for the same at the earliest.

• This option may be exercised by the concerned Government servants latest by **31.08.2023**.

- Option once exercised shall be final.
- Those Government servants who are eligible to exercise the option, but do not do so by the stipulated date, shall continue to be covered by the National Pension System.

It is emphasized that although the last date for submission of option is 31.08.2023, efforts may be made for early submission, so that the process may be completed by the due date, i.e. 31.10.2023.
