Numerous objections have been received from officials of DA Cadre of Bihar and Jharkhand, regarding provisional revised seniority of DA Cadre published vide O.O. No. WM-I/Seniority-V/ dated 19.03.2026.

As most of the objections are similar in nature, a consolidated reply is being provided below:

Sl.	Objection	Reply
1.	Despite orders of CAT in 04 other states to withhold the retrospective implementation of Headquarter Letter dated 17.04.2017 and 25.02.2019, the same has been applied retrospectively in Jharkhand.	Headquarters Office had issued instructions for revision of seniority of DA Cadre vide Circular No.10/ Staff Wing/2019 issued under letter No. 297- Staff (Apptt)/137-2019 dated 25.02.2019 and further clarification received vide letter no.270-Staff (App)/ 137-2019 dated 20.03.2020. Further, specific instructions have been received vide Headquarter Office Letter No. 862-Staff Niyukti-III/174-2023 dated 16.09.2025, that the revised seniority of directly recruited Divisional Accountants may be fixed in accordance with Headquarters guidelines issued vide letter dated 03.07.2024. Detailed guidelines have also been received vide Headquarters letter no.64/ Staff Niyukti-III/140-2023 dated 16.01.2026. Thereafter, the seniority list has been prepared and published in accordance with all the above Headquarter instructions.
2.	Non application of instructions of Headquarters received vide Letter dated 19.05.2025, regarding implementation of orders of CAT, Rajasthan.	
3.	Retrospective application of Para 10.2.1 of MSO (Admn) Vol.I and Non-Determination of seniority as per DAGE rank, in contravention to CAT orders.


