

Allocation of State/office to the candidates nominated for appointment to the post of Data Entry Operator Grade 'A' through Combined Higher Secondary (10+2) Level Examination, 2018 in Indian Audit & Accounts Department (IA&AD)

The Staff Selection Commission had nominated 48 (SC-06, ST-04, OBC-12, EWS-05, UR-21) candidates for appointment to the post of Data Entry Operator Grade 'A' through Combined Higher Secondary (10+2) Level Examination, 2018.

2. Among the 48 candidates, 42 have submitted the online required details of their Bio-Data, State Preference and Attestation Form.
