- ii) The retired officers shall not be hired on short term contract basis beyond the age of 65 years.
- Remuneration and allowances payable to retired officers/officials will be governed by OM No. 3-25/2020-E.III A dated 09/12/2020 issued by the Department of Expenditure, Ministry of Finance, Gol, New Delhi, which is as under:
 - a) The retd. Officers/officials shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract.
 - b) An appropriate and fixed amount as transport allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
 - c) No annual increment/percentage increase, Dearness Allowance and HRA shall be allowed during the contract.
 - iv) Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service to the retd. officials hired on short term contract basis. Accumulation of leave beyond a calendar year may not be allowed.

It may be noted that the appointment will be purely on temporary basis subject to termination at any time.

Interested retired personnel may submit their applications in the enclosed proforma to this office latest by 16, June 2022. Preference would be accorded to retired officials having computer knowledge.
