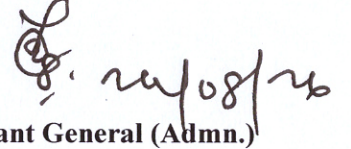

2. The promotion/notional promotion made in terms of Circular No. 6-Staff (Appt-III)/2025 issued vide letter No. 70-Staff (Appt-III)/165-2024 dated 29.01.2025 shall be subject to the outcome of O.A. No. 1450/2025 pending before the Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi.
3. They are to report to Admn.-I Section of this office to take over charge as Senior Audit Officer.
4. The promotion is being offered to the above AAOs against supernumerary posts created by Headquarters' Office vide letter dated 04.07.2025.
5. The promotion is subject to the judgement dated 28.01.2022 of the Hon'ble Supreme Court of India in Jarnail Singh and others in Civil Appeal No. 629/2022 arising out of SLP (C) No. 30621/2011, and further orders that may be passed by the Hon'ble Supreme Court in the said batch of cases. Further, the promotion shall be subject to the conditions mentioned in DoPT's O.M. dated 12.04.2022.
6. In terms of para 5 of DOPT O.M. No. 36012/11/2016-Estt.(Res-I) (Pt-II) dated 15.06.2018, the promotions shall be subject to further orders which may be passed by the Hon'ble Supreme Court.
7. There shall be a probation period of 02 (two) years on their promotion to the Senior Audit Officer cadre, as per Column (9) of the schedule of the Recruitment Rules for the post of Senior Audit Officer, notified in Gazette of India, Part II Section 3 Sub-Section (i) vide GSR No.860(E) dated 18.11.2019 published in Gazette of India on 20.11.2019.
8. They may exercise option within one month from the date of issuance of this office order for fixation of pay under the provisions of FR 22-I(a)(1)/C.C.S. (RP) Rules, 2016.

9. Promotion extended vide this office order, may be reviewed on subsequent clarifications/orders/instructions received from Headquarters' Office.
