Senior Audit Officers/Assistant Audit Officers/Supervisors/Asst. Supervisors/Senior Auditors/Auditors willing to be considered for deputation to Central/State Government offices/Autonomous bodies/Public sector undertakings in Tamil Nadu and other States for the Panel Year 2023-24 may give their willingness in the prescribed proforma, through proper channel on or before 14.07.2023 to Administration II section. The list will normally be valid for one year. The Officials working in the Office of the PAG (Audit-II), TN & Puducherry and PDA(Central) should submit the filled in proforma to their respective Offices and the same is to be forwarded with the recommendations of the Principal Accountant General/Principal Director of Audit (Central), Chennai.

On the closing date of receipt of applications the applicant

- should not have crossed the age of 56 years (i)
- should be confirmed in the respective cadre. (ii)
- should have served atleast for a period of 05 years in the parent office. (iii)

It is to be noted that an Officer/Official who declines to proceed on deputation after selection will be barred from further deputation for a period of one year.

Officers/Officials who have come back from deputation outside IA&AD will not be considered for any other deputation before he/she completes three years of cooling-off period. It should also be noted that the period of deputation will not, normally exceed four years in or outside IA&AD.

This issues with the approval of the Principal Accountant General.
