## CIRCULAR No.15

- 1. A reference is invited to Rule 18(1)(ii) of the Central Civil Services (Conduct) Rules 1964 and according to which every Government Servant belonging to any service or holding any post included in **Group 'A'**, **Group 'B'** and **Group 'C'** (including MTS) shall submit an annual return giving full particulars regarding immovable property inherited by him or owned or acquired by him or held by him on lease or mortgage either in his own name or in the name of any member of his family in the name of any other person.
- 2. All Group 'A'(IA&AS) may upload in the SPARROW and Group"A" (Non-IA&AS), Group 'B' and Group 'C' (including MTS) staff of this office are requested to furnish the return on Immovable Property for the year 2020 (as on 01.01.2021), which is required to be filed by the 31st January 2021, in the prescribed form enclosed. The complete details of all Immovable Properties owned, acquired, inherited or held on lease or mortgage in respect of self and dependents should be furnished. In cases where there are no change(s) during the year 2020, with regard to immovable property, the annual return may be merely endorsed with the words "No change" or "Same as last year". The forms may also be superscribed "Self and Dependents" separately.
  - 3. The returns may kindly be sent to the undersigned on or before 31.01.2021
