Minutes of the meeting of the Departmental Screening Committee for evaluating the suitability of Shri. Vibhakar Shivaram R., S/o Late Ramiah E., Ex. Senior Audit Officer, Office of the Accountant General (Audit-II), Kerala, Thiruvananthapuram for compassionate appointment in the Office of the Accountant General (Audit-I) Kerala

The Departmental Screening Committee consisting of Dr. Anish D., Senior Deputy Accountant General (Admn. & AMG – I), Office of the Accountant General (Audit – II), Kerala, Shri. Prinson Varghese, Senior Deputy Accountant General (AMG – I), Office of the Accountant General (Audit – I), Kerala and Shri. Naseef Abdul Kader, Senior Deputy Accountant General (AMG – II), Office of the Accountant General (Audit – I), Kerala as members met on 09.09.2025, for considering the application received from Shri. Vibhakar Shivaram R., S/o Late Ramiah E., Ex. Senior Audit Officer, Office of the Accountant General (Audit – II), Kerala, Thiruvananthapuram, for appointment on compassionate grounds in the Office of the Accountant General (Audit-I), Kerala.

The Committee went through the report submitted by, Welfare Officer, Office of the Accountant General (Audit I), Kerala, with regard to the pecuniary and other conditions of the family. The Committee noted that Shri. Ramiah E., who was working as Senior Audit Officer in the Office of the Accountant General (Audit-II), Kerala, Thiruvananthapuram, expired on 03.02.2025 at Thiruvananthapuram. The Committee noted that at the time of death, Shri. Ramiah E., had a total service of 34 years 01 month 15 days as he joined service w.e.f. 20.12.1990. He was left with a service of 3 years 3 months 25 days, as his date of birth being 19.05.1968.

The Committee considered the verification report submitted by Welfare Officer, Office of the Accountant General (Audit-I), Kerala and noted the following facts:

- (i) Late Ramiah E., is survived by his wife Ms. R., Manimekalai aged 49, son Mr. Vibhakar Shivaram R., aged 22 years and daughter Ms. Lakshmi Priya R., aged 24 years.
- (ii) Mr. Vibhakar Shivaram R., in whose favour the compassionate appointment is sought, is 22 years old (Date of Birth:05.02.2003), and his educational qualification is Bachelor's Degree in Physical Education. Course completed and result declared as passed.
- (iii) The family resides at rented house at Mannamoola, Peroorkada, Thiruvananthapuram
- (iv) None of the family members are employed.
- (v) The family does not own a house of their own.
- (vi) Smt. Manimekalai has requested to consider her son Shri. Vibhakar Shivaram R., for compassionate appointment (request dated 11.04.2025).

- (vii) Ms. Lakshmi Priya R., daughter of Late Ramiah E., has expressed her consent (consent letter dated Nil) for employment under compassionate grounds to her brother, Shri. Vibhakar Shiyaram R.
- (viii) Immovable property owned by Shri. Ramiah E., is as under:
 - a) 2 Ares 6 Sqm. land, Resurvey Nos.16/1 and 16, Mannamoola, Peroorkada of fair value amounting to Rs.7,06,992/-
 - b) 9. 5 Ares (24 cents) of land, Survey No. 19/3 in Keelaveeragavapuram Village, Tirunelveli District of fair value amounting to Rs.5,22,177/-

The Committee noted that the total posthumous benefits received by the family of the deceased is ₹44,92,512/- arrived from the following sources: - (i) Death cum Retirement Gratuity - ₹25,00,000/- (ii) Leave encashment - ₹17,72,148/- (iii) Central Government Employees Group Insurance Scheme- ₹1,97,200/- (iv) Differential leave encashment of ₹23,164. Payments in respect of all the posthumous benefits were received by the family.

The Committee also noted that leave encashment amounting to ₹17,72,148/- was adjusted against outstanding loans (Personal Computer Advance - ₹ 19,862/- AG's office Employees Co-operative Credit Society - ₹ 2,91,548/- and AG's Office Gazetted Officer's Society -₹ 14,60,738/-. The family received an amount of ₹1,03,445/- as closure of General Provident Fund. The family also received an amount of ₹3,50,000/- from LIC as sum assured on death.

Ms. Manimekalai is receiving a family pension of ₹59,500 /- plus dearness relief per month from 04.02.2025 to 03.02.2035 and ₹35,700/- (reduced rate) per month from 04.02.2035.

The Committee noted that as per the Scheme of Compassionate appointment, the objective of the scheme is to grant appointment on compassionate grounds to a dependent family member of the Government servant dying in harness or who has retired on medical grounds, thereby leaving his family in penury and without any means of livelihood, to relieve the family of the Government servant concerned from financial destitution and to help it get over the emergency.

As per the procedure contained in Appendix to O.M.No.43019/9/2019-Estt.(D) dated 23rd August 2021, every valid application shall be assessed strictly on the basis of the point based merit system formulated by the concerned administrative Ministry/Department and also the Committee should make its recommendation for appointment on compassionate ground as per the points obtained by each Applicant, under the applicable point based merit system. Headquarters office as per Annexure V to circular No.14 dated 20.04.2022 has revised the evaluation system for short listing applications for appointment on Compassionate Grounds.

Bennight Park The Committee carefully examined the report submitted by Welfare Officer, Office of the Accountant General (Audit-I), Kerala other facts/ documents submitted before the Committee and evaluated the case as per the revised model Evaluation System circulated vide Headquarters Office Circular No.14 in File No.52-Staff Entt. (Rules)/A.R/02-2021 dated 20.04.2022.

The Committee noted that:

- 1. The deceased official is survived by his wife Ms. Manimekalai R., aged 49, unmarried daughter Ms. Lakshmi Priya R., aged 24, who is a student and unmarried son Shri. Vibhakar Shivaram R., aged 22.
- 2. The family has no means of livelihood other than the family pension of ₹ 59,500/- + DR per month (₹35,700/- reduced rate from 04.02.2035 + DR) to meet domestic expenses and educational expenses.
- 3. The family does not own a house.
- 4. The son of the deceased, for whom the compassionate appointment is sought is unemployed and has just completed his studies.
- 5. The educational qualification of applicant is graduation (BPEd).
- 6. Out of the total posthumous benefits amounting to Rs.27,20,364/- (DCRG + CGEGIS + DLE), an amount of Rs.25,28,549/- was utilised for settling the liabilities of the family. Also an amount of Rs.17,72,148/- received as leave encashment was adjusted against the personal computer advance and the liabilities that were outstanding in A.G's office employees credit society and Gazetted officers' society.

The Committee also noted that in Group 'C' cadre 5% of direct recruitment vacancies i.e, 7.70 vacancies (rounded of to 8 vacancies) are available for appointment on Compassionate Grounds during the remaining part of panel year 2025.

The Committee considered the above facts including the assets and liabilities of the family and observed that the family of the deceased is presently facing severe financial crisis and is in a state of penury. An employment to the dependant son of the deceased employee would enable the family to tide over the sudden crisis and relieve the family of the deceased from financial destitution. Thus, the Committee came to the conclusion that Shri. Vibhakar Shivaram R., son of Late Ramiah E., is a FIT candidate for appointment under compassionate grounds. Therefore, considering the educational qualification of the applicant, the Committee recommended Shri. Vibhakar Shivaram R., son of Late Ramiah E., for appointment on compassionate grounds to the post of Auditor, in the offices under the cadre control of Accountant General (Audit – I), Kerala.
