## **CIRCULAR**

Subject: Departmental Examination for Accountants in August 2024

The next Departmental Examination for Accountants (DEA) is scheduled to be held centrally by Examination Wing of Headquarters office on offline mode in the month of August 2024 as per Hqrs' Circular No. 01 of 2024 vide letter No. 15/15-Exam/Exam Conducting Centrally/2023 Dated 17.01.2024. As per revised Chapter 9, Para 9.4 of MSO (Admn) Vol-I (revised) and in terms of Headquarters Circular No.5-Staff (App1)/2022 issued vide letter No. 157-Staff (App 1)/18-20 Dated 04.02.2022, the officials who fulfil the below stated conditions are allowed to appear the DEA Exam., August 2024.

- Directly recruited Accountants, who would be completing one-year continuous service on 01.08.2024 will be eligible to appear in the examination.
- Clerks promoted to Accountants on seniority basis may appear in the examination immediately after their promotion. They may however, not appear in the examination if it is held within 90 days of their promotion. They may instead appear in their first examination held immediately thereafter.
- iii) All Graduate Group C officials with three years continuous regular service as on 01.08.2024.
- iv) The reverted clerks, who are failure to pass the DEA Examination within stipulated time, will have three more consecutive chances to clear this examination within two years of the reversion.

**Note**: SAS Group I passed officials promoted to the post of Accountants are not required to pass the Departmental Examination for Accountants for promotion to the higher scale of Sr. Accountant.

Principal Accountants General may at their discretion, condone deficiencies in the prescribed service, of one year in respect of directly recruited Accountants and three years in respect of Group C Officials up to a limit not exceeding two months.

The eligible candidates are required to submit their applications furnishing inter-alia the particulars in prescribed proforma through proper channel so as to reach the Establishment Section on or before 30.07.2024. The examination will be held on the revised syllabus. Revised syllabus of the examination will be communicated in due course. The existing number of chances will continue. The counting of the number of chances would start afresh from the beginning of conducting the exam centrally. Previous exemption will continue to be valid. Examination will be held in MCQ Pattern and duration of Examination is two hours. Books are not allowed in this examination. The number of questions for each paper based on the MCQ pattern will be 100. Pass and exemption marks will be 45% in each paper. Negative marking to the extent of 0.25 Mark (25 percent) is applicable for each wrong answer of MCQ.

The date, time and venue of the examination will be intimated in due course.
