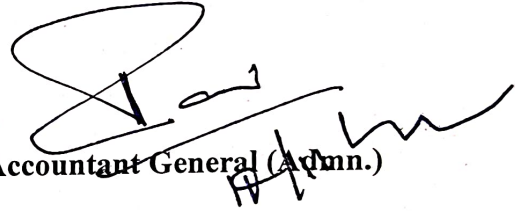
Sub: - UN Audit participation of Principal Accountant General and Additional charges thereon-reg

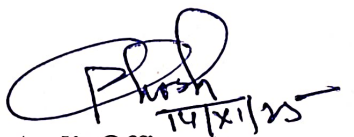
