### NOTICE

Applications are invited from eligible retired Senior Accounts Officers for hiring on short term contract basis as Consultant against the vacancies available in the cadre of Sr. Accounts Officer for taking up the work of finalizing the pension and GPF cases in Entitlement Group of Office of the Principal Accountant General (A&E), Andhra Pradesh, Vijayawada.

The Brief terms and conditions which will be applicable to the officers hired will be as under:

- i. The Consultant would initially be hired for a period of one year and the maximum number of terms shall be restricted to five. No retired officer shall be hired beyond the age of 65 years. Further, the term of appointment will be purely on temporary basis and is subject to termination at any time as per administrative convenience.
- ii. Remuneration and allowances payable will be governed by OM No.3-25//2020-E.III A dated 09.12.2020, issued by the Departmental of Expenditure, Ministry of Finance, Government of India, New Delhi.
- iii. The hired consultant shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of contract and there will be no annual increment/percentage increase, Dearness Allowance and House Rent Allowance during the contract period.
- iv. An appropriate and fixed amount as Transport Allowance for the purpose of commuting between residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
- v. Statutory deductions levied by the Government shall be made as per rules.
- vi. Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed.
- vii. If the Consultant remains absent beyond paid leave in a month, his/her remuneration shall be deducted on pro-data basis as under.
