Sub: Central Civil Services (Conduct) Rules, 1964 - Submission of Declarations of Immovable Property Returns and Transactions in shares, debentures, securities etc. by the Govt. Servants - Regd.

In accordance with the provisions contained in Rule 18(1)(ii) and O.M. No. F.No. 11013/7/2014-Estt.A-III dated 05.01.2016, issued by Ministry of Personnel, Public Grievances and Pensions, Deptt. Of Personnel & Training, **all Sr. Audit Officers, and staff of this office belonging to Gr. "B", Gr. "C" and erstwhile Gr. "D"** are required to submit an annual return (referred as Annexure-I) of immovable property inherited by him or owned or acquired by him or held by him on lease or mortgage either in his own name or in the name of any member of his family or in the name of any other person.

Further, in terms of the O.M. No. F.No.11013/6/2018-Estt.A-III dated 07.02.2019 issued by Ministry of Personnel, Public Grievances and Pensions, Deptt. Of Personnel & Training., **all Sr. Audit Officers as well as Gr. "B", Gr. "C" and erstwhile Gr. "D" officials** are required to submit an annual return (referred as Annexure-II) of detailed transactions of sale, purchase or both in shares, securities, debentures, mutual fund schemes etc., ***if the total transactions exceeds six months' basic pay of Government servant during the calendar year.***

Annexure-I in duplicate *i.e.* one for self and the other for the members of the family of the Govt. Servant, and Annexure-II, for the year ending on 31.12.2025 may be submitted to Admn.III Section **on or after 01.01.2026 but within 31.01.2026** for taking further necessary action at this end.

Also, as per Hqrs. Circular No. 03-Staff (Disc.-I)/2024 vide letter No.272/Staff(Disc-I)/11-2024 dated 22.01.2024, **all Sr. Audit Officers of this office** are required to fill their Annual Immovable Property Return (IPR) online in SPARROW portal instead of Annexure-I for the

year 2025 and the copy of the same, along with Annexure-II (mentioned above) are to be submitted in Admn.III Section.

Branch Officers concerned are requested to inform the officials under their control.

It may be noted that failure to comply with the requirement of the aforesaid rule will form good and sufficient reason for instituting disciplinary proceedings against the erring officials. Strict action may be taken against employees who fail to submit the returns in time or furnishing wrong information. Further, in terms of DoPT. OM No. 11012/11/2007-Estt.A dated 27.09.2011, the officers are also informed that non-submission of Annual Immovable Property Returns within the stipulated date, would invite the denial of vigilance clearance and they will not be considered for empanelment for senior level posts in Government of India.
