2. NFU will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial upgradation under MACP, if any, is to be reckoned from the date of grant of NFU.
3. Due to re-fixation of pay subsequent to grant of NFU, arrears of pay and allowances will be paid to the officials as admissible under 7<sup>th</sup> CPC.
4. The benefit of financial upgradation under the NFU, extended vide this office order, may be reviewed on subsequent clarification/order/instruction received from Headquarters.
