

**PROCEEDINGS OF THE DEPARTMENTAL SCREENING COMMITTEE FOR
APPOINTMENT ON COMPASSIONATE GROUND FOR THE YEAR 2026.**

The Departmental Screening Committee comprising Ms. Veenus Chaudhary, Sr. Deputy Accountant General (Administration & Works), O/o the Principal Accountant General (Accounts & Entitlement), Haryana, Chandigarh, Sh. Aditya Pant, Sr. Deputy Accountant General (AMG-III), O/o the Principal Accountant General (Audit), Haryana, Chandigarh and Ms. Inabat Khaliq, Director, O/o the Director General of Audit (Defense Services), Chandigarh held its meeting on 25.02.2026 to consider the following cases for appointment on compassionate ground:-

2. The Committee was informed that Govt. of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, New Delhi vide F. No. 14014/01/2022-Estt. (D) Dated 02.08.2022 has consolidated the earlier instructions on the Scheme for Compassionate Appointment under Central Government by including contents of all the important/relevant OMs issued till date.

3. The committee noticed that the basic objective of the scheme is to grant appointments on compassionate grounds to a dependent family member of a Govt. Servant who died in harness or retired on medical grounds thereby leaving his/her

family without any means of livelihood and to relieve the family concerned from financial destitution and to help it get over the emergency. Meaning thereby that the basic criteria for the appointment must be to ascertain whether the death or retirement on medical grounds of the Govt. Servant, had left the family in financial destitution and penury without any means of livelihood.

4. The Committee was informed that 04 vacancies (**01 in Auditor, 01 in Clerk and 02 in MTS cadre**) in Group 'C' cadre for compassionate appointments for the year 2026 are available.

5. The Committee was apprised that two (02) applications for compassionate appointment were pending in the office of the Principal Accountant General (Audit), Haryana, Chandigarh for the year 2026. Out of these, one (01) was a fresh application submitted by Sh. Himanshu, son of Late Sh. Sunil Kumar, Assistant Supervisor, for consideration. The other one (01) was a previous application/representation submitted by Shri Ravi, son of Late Shri Chander Pal, Senior Auditor, for reassessment/reconsideration. The brief of the cases is as follows: -

(a) Sh. Himanshu s/o late Shri Sunil Kumar, Assistant Supervisor

Smt. Suresh Devi W/o Late Shri Sunil Kumar, Assistant Supervisor, has applied on 10.03.2025 and 17.03.2025 for appointments to her son Shri Himanshu on compassionate ground. As per report of Sr. AO Welfare, Late Shri Sunil Kumar expired on 24.01.2025 leaving behind 02 children (29 years old unmarried Son and 23 years old married daughter). The Candidate is 10th Pass, unemployed and at present residing at House No. 2078-B, Sector-41/C, Chandigarh.

Further, the family of the deceased have received the total terminal benefits of Rs. **34,27,053/-** as under:

- i. DCRG of Rs. 25,00,000/-,
- ii. Leave encashment – Rs. 8,33,641/-,
- iii. CGEGIS – Rs. 33,412/-,
- iv. DLIS- Rs. 60,000/-,
- v. Family pension- Rs. 35,000/-+DA per month (enhanced rate up to 24.01.2035) thereafter, at normal rate i.e Rs. 21,000/-+DA

As per bank passbook of Smt. Suresh Devi (Account No. 5064100100008810 of PNB, Chandigarh) there was a closing balance of Rs. 37,490.53/- on 24.09.2025. In addition, the family has immovable property (House No. 123, Golu Majra, Derabassi, Mohali, Punjab) with a Fair Market Value 43.00 lakhs. However, the family has a Home Loan amount of Rs. 27,00,000/-. They have moveable property Car bearing Registration No. CH01AT4274.

As is evident from above that the family of the deceased officials have received a terminal benefit of Rs. 34,27,053/- and monthly pension of Rs. 35,000/ plus DA per month. At the time of death of the official, the remaining service left was 03 years 5 months 7 days. Further, the family has closing balance of Rs. 37,490.53/- on 24.09.2025 and has 01 married daughter and 01 unmarried sons.

Thus, it is clear that the family of the deceased has not been left in financial destitution and penury without any means of livelihood. Hence, the Committee does not recommend the case of Sh. Himanshu S/o Late Shri Sunil Kumar, Assistant Supervisor for appointment under compassionate grounds in office of the Principal Accountant General (Audit) Haryana, Chandigarh.

(b) Shri Ravi son of Late Shri Chander Pal, Senior Auditor

Shri Ravi, son of Late Shri Chander Pal, Senior Auditor, applied on 18.06.2020, for his appointment on compassionate grounds. As per report of the Welfare Officer, Sh. Chander Pal, Senior Auditor expired on 02.03.2020.

Further, the family of the deceased have received the total terminal benefits of **Rs. 32,64,439/-** as below:

- i. DCRG of Rs. 20,00,000/-,
- ii. Leave encashment – Rs. 8,19,000/-,
- iii. CGEGIS – Rs. 1,23,351/-,
- iv. DLIS - Rs. 60000/-,
- v. GPF – Rs. 2,56,668/-,
- vi. Pay Arrears (01.03.2020 to 02.03.2020) – Rs. 5,420/-
- vii. Family pension- Rs. 35,000/-+DA per month (enhanced rate up to 02.03.2030) thereafter, at normal rate i.e Rs. 21,000/-+DA

Apart from the above, as per Welfare Officer Report, the family of Late Shri Chander Pal, Sr. Auditor, has no house, property or land area (immovable property).

The Committee was informed that the case of Shri Ravi had not been found 'FIT' for compassionate appointment in the earlier Departmental Screening Committee meeting held in 2020. Shri Ravi vide representation dated 04.06.2021 and 19.08.2021 has submitted applications to reconsider his case for appointment on compassionate grounds. The competent authority has not acceded approval to the applications of the applicant.

Further, Hqrs' office vide letter No. **31-स्टाफ हक. (नियम)/सी.ए/04-2020** dated 18.05.2022, has clarified that the competent authority to make compassionate appointment is the Head of the Department and the decision in all other cases may be taken by the Head of the Department and an appropriate decision may be taken as per the provisions of DoPT OM dated 16.01.2013.

Subsequently, Shri Ravi has filed an OA No. 060/1054/2022 in the Hon'ble CAT, Chandigarh Bench on 10.10.2022. The Hon'ble CAT, Chandigarh Bench, vide order dated 11.09.2025, has directed the applicant to submit the documents within a period of four weeks to the respondents for consideration/assessment of his financial distress and consideration of his compassionate appointment. Furthermore, Hon'ble CAT, Chandigarh Bench has stated that 'The applicant at the time of submitting his applications for considering his case for compassionate appointment, nowhere disclosed what was his source of income after the date of his graduation' and the respondents to take further 4 weeks to pass a speaking order in case of the applicant. Shri Ravi submitted a representation dated 21.09.2025 in pursuance of the order passed by the Hon'ble CAT, Chandigarh Bench.

The Committee was informed that the O/o the Principal Accountant General (Audit), Haryana, Chandigarh, vide letters dated 22.10.2025, 14.11.2025, 20.11.2025, and 13.02.2026, sought additional documents and information from Sh. Ravi. The applicant has provided additional information and documents regarding his employment with Kesari Bani Media Pvt. Ltd. It has been observed from Income Tax Returns for the Assessment Years 2024-25 and 2025-26 of the applicant that he is earning an approximate salary of ₹27,000/- per month.

Accordingly, the Committee affirms the recommendation of the earlier Committee.
