NOTICE

This office requires the services of 05 retired Sr. AOs/AAOs in the cadre of AAOs and 10 retired Supervisors/Asstt. Supervisors/Sr. Acctt./Accountant in the cadre of Accountant as consultants on short term contract basis from the retired officers/officials of IA&AD. The retired persons who will be selected for appointment as consultant would be initially engaged for a period upto 31-03-2024 subject to performance and requirement of his/her services. **The retired officials should have sufficient experience in dealing with pension work.** Besides above, this office also requires the services of 01 retired Sr. AOs/AAOs in the cadre of AAOs for appointment as consultant on short term contract basis for work of allotment of GPF Account numbers of the State Govt. employees. The retired person who will be selected for appointment as consultant would be initially engaged for a period upto 31-12-2023 subject to performance and requirement of his/her services. The retired persons engaged on short term contract basis shall be paid fixed monthly payment, arrived at by deducting the basic pension from the pay drawn at the time of retirement in terms of Headquarters' letter No. 08-Staff Entt. (Rule)/A.R./01-2019 (Part-II) dated 11-01-2021. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment/percentage increase & DA during the contract period.

2. An appropriate and fixed amount as transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.

3. Leave: Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service to the retired officials/CAs/CMAs hired on short term contract basis. Accumulation of leave beyond a calendar year may not be allowed. However, absence during curfew, bandh, strike, lockdown should be dealt with in a similar way as in the case of serving officers/officials as these are events beyond the control of any individual.

The maximum age limit of retired personnel for engagement as consultant shall be 65 years. Hence, retired personnel who have attained the age of 65 years need not to apply.

It may be noted that the appointment will be purely on temporary basis subject to termination at any time without assigning any reason.
