**NOTIFICATION**

Applications are invited from eligible candidates for the following Examination 1 of SAS/Incentive/CPD 2021 :

**A. SAS Examination – Civil Accounts / Civil Audit Stream.**

Existing candidates, fresh candidates (who have completed 2 years of regular service in one or more cadre of Clerk, DEO Grade A, DEO Grade B, Accountant, Senior Accountant, Assistant Supervisor, Supervisor, Junior Translator, Senior Translator, Personal Assistant, Divisional Accountant, Divisional Accounts Officer Grade II, who have completed probation as on 01/03/2021 and the mandatory pre examination training) are eligible to appear either in the SAS Civil Accounts or Civil Audit Stream by submission of a written undertaking. The option once exercised may not be changed at a later date. Officials who have attained 56 years of age, shall not be eligible to appear for the Civil Audit Stream. *Officials who have already exhausted ten chances are allowed two more chances in the same stream and have to avail the two chances within four examinations counting from Examination 1 of 2021.*

**B. Incentive Examination for AAO/Sr.AO/DAO Gr.I/Sr.DAO**

Officers who have completed one year of regular service in the cadre of AAO (RT) and DAO Gr.I as on 01<sup>st</sup> March 2021 are eligible. *Officers who have already exhausted six chances are allowed two more chances and have to avail the two chances within four examinations counting from Examination 1 of 2021.*

**C. CPD I Examination :**

Sr.Accounts Officers and AAOs who have completed four years of regular service as on 01/03/2021 are eligible. *Officers who have already exhausted six chances are allowed two more chances and have to avail the two chances within four examinations counting from Examination 1 of 2021.*

**D. CPD II Examination :**

Officers who have completed 04 years of service as on 01/March/2021 after the passing of CPD I examination are eligible. *Officers who have already exhausted six chances are allowed two more chances and have to avail the two chances within four examinations counting from Examination 1 of 2021.*

**E. CPD III Examination :**

Officers who have completed 03 years of service as on 01/March/2021 after the passing of CPD II examination are eligible.
