Sub: Incentive Examination for Senior Auditors to be held in July 2020.


Incentive examination for Senior Auditors for the year 2020 which was scheduled to be held on 17.04.2020 and was cancelled will be conducted on **07th August 2020, Friday** in the Meeting Hall (7th Floor), Lekha Pariksha Bhavan, 361, Anna Salai, Teynampet, Chennai – 600 018.

10.00 AM to 12.30 PM	One paper on Finance Accounts and Audit (Max. Marks: 100)

Senior Auditors with one year of continuous service in the grade as on 01.04.2020 and who have not reached the maximum in their pay scale are eligible to appear in the examination. The examination should be written **without the aid of books**. Candidates have the option to answer the paper either in Hindi or in English.

Candidates should secure a minimum of 50% marks to qualify in the examination. Candidates who qualify in the examination will be granted one advance increment from the first of the month in which the examination is held.

Senior Auditors of the Offices of the Principal Accountant General (Audit-I), Tamilnadu, Accountant General (Audit-II), Tamilnadu & Puducherry and Director General of Audit (Central), Chennai, who fulfil the eligibility criteria and wish to appear for the said Examination may submit their applications with the recommendation of the Branch Officer to Administration II Section of this Office on or before **20.07.2020**. **Officials who have already submitted applications for the test which was scheduled in April 2020 are to submit fresh applications.**
