Applications in the prescribed proforma (enclosed) for one post of Sr. Accounts Officer are invited from retired Sr. AOs/AOs of Indian Audit & Accounts Department to provide services as Sr.AO on short term contract basis as per following terms and conditions envisaged in HQ's circular No. 27/2021 No. 967-Staff(APP I)/22-2016 dated 03.08.2021:-

(1) Eligibility: - Retired Sr. AOs/AOs with specific experience in EDP matters related to the working of entitlement functions of O/o the PAG (A&E) shall be eligible.

(2) **Tenure and age limit:** - The retired officer will be hired initially for a period of one year or until the existing vacancies in Sr.AO cadre are filled on regular/ad-hoc basis, whichever is earlier. The maximum number of terms shall be restricted to five. No Retired Officer shall be hired beyond the age of 65.

(3) **Remuneration and Allowances:** -The retired officer will be paid fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract. An appropriate and fixed amount as transport Allowance for the purpose of communication between the residence and the place of work shall be allowed not exceeding rate applicable to the appointee at the time of retirement. No annual increment/percentage increase, D.A. and HRA shall be allowed during the contract.

(4) Leave: - Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of service to the retired officer hired on short term contract basis. Accumulation of leave beyond a calendar year will not be allowed. However, absence during Curfew, Bandh, Strike, Lockdown will be dealt with in a similar way as in the case of serving officials as these are events beyond the control of any individual.

If retired officer remains absent, beyond paid leave in a month for reasons other than those indicated above, his/her remuneration shall be deducted on pro-rata basis as under:-

Fixed monthly remuneration X No. of day of absence on working days

(5) **Duties assignable and other conditions:** - The retired officer shall not sign in PPOs, GPF statements, monthly accounts and correspondence etc. The retired officer shall be deployed as per his work experience indicated above.
