## PROCEEDINGS OF THE DEPARTMENTAL SCREENING COMMITTEE FOR APPOINTMENT ON COMPASSIONATE GROUND FOR THE YEAR 2023.

The Departmental Screening Committee comprising Ms. Sumedha Amar, Sr. Deputy Accountant General (Admn), O/o the Principal Accountant General (Audit), Haryana, Chandigarh, Shri Ranjeet Singh, Sr. Deputy Accountant General (Admn), O/o the Principal Accountant General (A&E), Haryana, Chandigarh and Ms. Shweta Mishra, Deputy Accountant General (AMG-I), O/o the Principal Accountant General (Audit), Haryana, Chandigarh held its meeting on 18 .12.2023 to consider the following cases for appointment on compassionate ground:-

- 2. The Committee was informed that Govt. of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, New Delhi vide F.No. 14014/01/2022-Estt. (D) Dated 02.08.2022 has consolidated the earlier instructions on the Scheme for Compassionate Appointment under Central Government by including contents of all the important/relevant O.Ms issued till date.
- 3. The committee noticed that the basic objective of the scheme is to grant appointments on compassionate grounds to a dependent family member of a Govt. Servant who died in harness or retired on medical grounds thereby leaving his/her family without any means of livelihood and to relieve the family concerned from financial destitution and to help it get over the emergency. Meaning thereby that the basic criteria for the appointment must be to ascertain whether the death or retirement on medical grounds of the Govt. Servant, had left the family in financial destitution and penury without any means of livelihood.
- 4. The Committee was informed that 04-vacancies (01-in Auditor, 01-in Clerk and 02-in MTS cadre) in Group 'C' cadre for compassionate appointment during the year 2023 are available.

5. The committee was apprised that there are four (04) cases pending for appointment on compassionate ground. The brief of the cases are as follows: -

### (a) Smt Reena Yadav w/o Late Shri Anuj Kumar, Assistant Audit Officer (Commercial).

Smt. Reena Yadav w/o late Shri Anuj Kumar, AAO (Comml) has applied on 28.12.2022, for appointment of herself on compassionate ground. The deceased Shri Anuj Kumar, AAO joined the department on 14.12.2012 and died (suicide) while in service on 06.12.2022. The remaining service left at the time of death was 24 years. Further, as per report of the Sr. AO Welfare. Late Shri Anuj Kumar left behind only daughter of 09 years old. The applicant is having B.Sc.. B.Ed. degree and currently unemployed and residing in Government Accommodation at House No. 1142A, Sector-41/B, Chandigarh. Further, the family of the deceased have received the total terminal benefits of Rs. 15,08,738/-as under:

- i. DCRG of Rs. 09,32,328/-,
- ii. Leave encashment Rs.5,11,486/-
- iii. CGEGIS Rs. 64,924/-,
- iv. Family pension-Rs. 28150/-+DA per month (enhanced rate up to 06.12.2032) thereafter. at normal rate i.e Rs. 16890/- + DA.

The deceased of the family owns 4-Kanal land in Ahmadpur Partal, Kosli, Rewari Haryana, at cost of Rs. 12,50,000.

As per bank pass book of Smt. Reena Yadav (A/c No. 00000033202651777of SBI) there was a closing balance of Rs. 13,94,035.14/- on 16.03.2023.

As is evident from above that the family of the deceased officials have received a terminal benefit of only Rs.15,08,738/- and have no other source of livelihood except monthly pension @ Rs 28150/- plus DA per month. Further, the family has no bank balance and has one minor child to take care and deceased officer died after rendering only 11 years' service, leaving the family in destitution.

Thus it is clear that the family of the deceased has been left in financial destitution and penury without any means of livelihood. Hence, the Committee recommends the case of Smt Reena Yadav w/o Late Shri Anuj Kumar, Assistant Audit Officer (Commercial), for appointment under compassionate grounds in office of the Principal Accountant General (Audit) Haryana. Chandigarh.

#### (b) Ms. Sanjana D/o Late Shri Rajbir Singh, Asstt. Supervisor:

Ms. Sanjana D/o Late Shri Rajbir Singh, Asstt. Supervisor has applied for appointment of herself on compassionate ground. The deceased have joined the department on 09.02.1993 and died while in service on 09.01.2023. The remaining service left at the time of death was 02 years 4 months. The deceased left his behind one daughter aged 24 who is unmarried. The applicant is having B. Com degree and currently unemployed and residing in Government Accommodation at House No. 1307-B, Sector-41/B, Chandigarh.

Further, the family of the deceased have received the total terminal benefits of Rs. Rs 38.01771-(including GPF of Rs 8.80 lakh) as under:

As per bank pass book of Ms. Sanjana (A/c No. 38160508791 of SBI) there was a closing balance 1000.00/- on 30.03.2023. The deceased of the family owns a plot measuring 20\*54 in Jyoti Nagar, Jagadhri, Yamuna Nagar, Haryana, at cost of Rs.11,50,000 and invested Rs. 15, 00,000 on construction. The family owes outstanding liability i.e loan of Rs. 5,38,870/-from ICICI Bank on aforesaid property. Further, the family has one scooter and do not have any other moveable or immovable property in Chandigarh or anywhere in India.

As is evident from above that the family of the deceased officials have received a terminal benefit of Rs. 38,01,771/- (including GPF of Rs 8,80,729) and monthly pension of Rs. 30,200/ plus DA and own an immovable property worth Rs. Rs.11,50,000. At the time of death of the official, the remaining service left was only 2 years & 04 months, and had he not died, he would otherwise have retired on attaining the age of superannuation after 2 years, thereby not leaving the family in destitution. Hence, the Committee does not recommend the case of Ms. Sanjana D/o Late Shri Rajbir Singh, Asstt. Supervisor, for appointment under compassionate grounds in office of the Principal Accountant General (Audit) Haryana, Chandigarh.

#### (c) Shri Sumit Kumar Singh S/o late Shri Devta Deen, Asstt. Supervisor:

Smt Vidyawati w/o Late Shri Devta Deen, Asstt. Supervisor has applied on 26.04.2023, for appointment of her son Shri Sumit Kumar on compassionate ground. The committee was informed that the deceased have joined the department on 22.12.1986 and died while in service on 06.04.2023. The remaining service left at the time of death was 03 years 02 months. Further, as per report of the Sr. AO Welfare, Late Shri Shri Devta Deen, Asstt. Supervisor, left behind 02 Sons (aged 32 married and 30 unmarried) and one Daughter aged (married). The applicant is 12<sup>th</sup> Pass and currently unemployed and at present residing at House No. - 1512-A, Sector-41/B, Chandigarh. Further, the family of the deceased have received the total terminal benefits of Rs.69,64,264 (including GPF of Rs 38.75 lakh) -as under.

- i. DCRG of Rs. 20,00,000/-,
- ii. Leave encashment Rs. 9,69,215/-
- iii. DLIS- Rs. 60,000/-
- iv. CGEGIS- Rs. 60,000/-
- v. GPF- Rs. 38,75,049/-
- vi. Family pension- Rs. 36,050/-+DA per month (enhanced rate up to 06.04.2033) thereafter, at normal rate i.e Rs. 21630/-+DA.

The family had also received Rs. 2,60,945/- as insurance claim from HDFC life insurance company. Further, there is an amount of Rs 7,09,610/- in the bank account of deceased as on 02.04.2023. The deceased of the family does not own any immovable property and has 02

motorcycles and one car as on 08.08.2023. The family owes outstanding liability i.e car loan of Rs. 2,50,000/-.

As is evident from above that the family of the deceased official have received a terminal benefit of Rs.69,64,264 (including GPF of Rs 38.75 lakh, had bank balance of Rs. 9,70,555/-, and monthly pension of Rs. 36,050-/ plus DA. At the time of death of the official, the remaining service left was only 3 years 02 months, and had he not died, he would otherwise have retired on attaining the age of superannuation after 3 years 02 months, thereby not leaving the family in destitution. Moreover, out of 03-children, 02-children of deceased are married and only son. to whom job is sought, is unmarried. Family has no outstanding liability except of car loan of Rs. 2,50,000/-

Hence, the Committee does <u>not recommend</u> the case of Shri Sumit Kumar Singh S/o late Shri Devta Deen, Asstt. Supervisor, for appointment under compassionate grounds in office of the Principal Accountant General (Audit) Haryana, Chandigarh.

#### (d) Ms. Vinita Pundeer D/o Late Shri Govind Singh, Asstt. Supervisor: -

Smt Shobha Devi w/o Late Shri Govind Singh, Asstt. Supervisor has applied on 16.05.2023. for appointment of her daughter Ms. Vinita Pundeer on compassionate ground. Shri Govind Singh, the deceased official joined department on 22.12.1986 and died while in service 23.04.2023. The remaining service left at the time of death was 03 months. Further, as per report of the Sr. AO Welfare, the deceased left behind 02 Daughter aged 29 years, 27 years. both unmarried. The applicant is MA (Hindi) and currently unemployed and at present residing at House No.- 1280-B, Sector-41/B, Chandigarh. Further, the family of the deceased have received the total terminal benefits of Rs. 71,69,531/-(including GPF of Rs 40 lakh) -as under.

- i. DCRG of Rs. 20,00,000/-,
- ii. Leave Encashment- 9,94,000/.
- iii. DLIS- Rs. 60,000/-
- iv. CGEGIS- Rs. 60,000/-
- v. GPF- Rs. 40,55,531/-
- vi. Family pension- Rs. 35,000/-+DA per month (enhanced rate up to 23.04.2033) thereafter, at normal rate i.e Rs. 21000+DA.

As per bank pass book of Ms. Vinita Pundeer (Account No. 34013218194 of SBI) there was a closing balance 24820/- on 04.08.2023. The Family has also received a sum of Rs. 2, 00,000/- as insurance claim from National Insurance Company.

The deceased of the family does not own any immovable property and has one motorcycles and one car. The family owes outstanding liability i.e car loan of Rs. 37,174/-.

As is evident from above that the family of the deceased official have received a terminal benefit of 71,69.531/-(including GPF of Rs 40 lakh) and monthly pension of Rs. 35,000/-/ plus DA. At the time of death of the official, the remaining service left was only 03 months and had he not died, he would otherwise have retired on attaining the age of superannuation after 3 months, thereby not leaving the family in destitution. Family has no outstanding liability except of a car loan of Rs. 35,000/-.

Hence, the Committee does <u>not</u> recommend the case of Ms. Vinita Pundeer D/o Late Shri Govind Singh, Asstt. Supervisor, for appointment under compassionate grounds in office of the Principal Accountant General (Audit) Haryana, Chandigarh.
