Sub: Holding of Pension Adalats on 20.09.2023.

(PUC Admn. I CAG Dy No. 299 dated 23.08.2023 may please be seen.)

Headquarters vide Circular No. 25-Staff Entt.-II/2023 issued under letter No. P-127/c 471/Staff Entt-II/54-2023 dated 18.08.2023 have intimated that as per the instruction of Ministry of Personnel, Public Grievances and Pension, Department of Pension & Pensioner's Welfare (copy enclosed), nation-wide Pension Adalats are to be conducted by Indian Audit & Accounts Department on 20.09.2023 for resolution of the pending PPOs. This Pension Adalat will cover the following:

- 1. Cases of retirement on superannuation till 30.06.2023 in which PPOs have not been issued till date.
- 2. Cases of voluntary retirement till 31.03.2023 in which PPOs have not been issued till date.
- 3. Cases of death of Government servants till 31.03.2023, in which family pension has not been sanctioned till date.
- 4. Cases of death of Government servants in the performance of duty till 31.03.2023, in which only provisional/ordinary family pension has been sanctioned and family pension under CCS (EOP) Rules has been claimed.
- 5. Cases wherein Death Certificate of the Pensioner has been submitted to Pension Disbursing Bank and Family pension not started within one month of receipt by the bank if the name of Family Pensioner is given in the PPO.

Further, it is intimated that all the remaining pending cases may be settled urgently and updated status may be intimated by 24.08.2023. The Group Officer in charge of Administration of the field offices are nominated as 'Nodal Officer' and are responsible for holding Pension Adalats in their respective office.

It is also intimated that all the necessary action to hold Pension Adalats may be taken immediately.

In view of the above, if approved, for successfully holding of pension adalat, advertisement, in one national daily, "The Times of India" and one local daily, "The Samaj" may be published for wide publicity as soon as possible so as to shortlist the cases at least by 11.09.2022. The same may also be hosted in the Office Website/Notice Board. On receipt of grievances, the cases will be shortlisted.

Further, Admn.-II, PAO and Gazetted seat of Admn.-I section may be intimated to submit the updated status of the above immediately for onward submission to Headquarters' by 24.08.2023.
