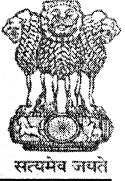



General Terms and Conditions of the Tender

- 1) The BIDDER must enclose adequate document to prove their authorization claims and if not, the Principal Accountant General (A&E), Manipur, Imphal reserves the right to accept or reject tenders of these agencies. The decision of the Principal Accountant General (A&E), Manipur, Imphal regarding this will be final and shall be binding on the bidders.
- 2) The rate both in words and figure without any corrections or overwriting should be quoted in Annexure I. In case any overwriting or re-writing or corrections has occurred, the same should duly be countersigned by the authorized signatory of the firm.
- 3) Rates quoted should be invariably for one year from the date of approval and inclusive of all taxes, transportation charges etc.
- 4) No increase in the rates will be accepted during the period of contract.
- 5) Delivery shall be made promptly within 24 Hours at the cost of the supplier at the locations on the basis of the supply order or as required by this office.
