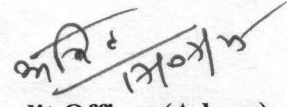
2. The final inter-se-seniority of these 76 AAOs as approved by the ADAI, is attached here with for information.

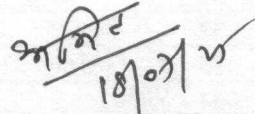
