2. Accordingly, sealed quotations are invited for the disposal of the said vehicle on the terms and conditions mention below. Person/firm, interested in purchasing the above mentioned vehicle, may submit their highest quotations in the enclosed Proforma in a sealed covered addressed to the undersigned **latest by 12.00 (Noon) on or before 22.02.2021 at the office of the Principal Accountant General (Audit), Jharkhand, Ranchi. Bid will be opened on the same date i.e 22.02.2021 at 3.00 P.M.** The bidders or their representatives, not more than one for each quotation, may be present, if they so desired, at the time of opening of Quotations. The cover should be prominently superscripted with the words **“QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE”**.

3. The vehicle will be available for inspection between 3.00 P.M to 5.00 P.M from 08.02.2021 to 19.02.2021 in presence of Sr. Audit Officer (Record & General) in all working days of the office.

4. **The Auction of the said vehicle will be governed by the following conditions:-**

- I. The vehicle will be sold on “As is where is basis”. The auction process will be conducted in the presence of Disposal of Goods Committee.
- II. The bidders are required to pay Earnest Money of ₹ 7000/- (Rupees Seven thousand only).
- III. Earnest Money is payable by means of Demand Draft drawn in favour of Pay and Accounts Officer (Audit), O/o Pr. Accountant General (A&E), Jharkhand, Ranchi (payment by cheque or cash shall not be accepted)
- IV. The Earnest Money of the successful bidder will be released only after deposit of the bid amount. Earnest money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. The case of failure to deposit final bidding amount, opportunity will be given to the next higher bidder.
- V. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
- VI. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Car, Aadhar Card etc. in case of individual and registration Certificate etc. in case of firms).
- VII. The auctioned vehicle will be removed by the successful bidder within 03 working days of depositing the bid amount, at their own expenses.
- VIII. The vehicle will be disposed off on “as is where is basis” and no guarantee for its worthiness or quality will be given by this Department.

- IX. This Department will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicles for commercial or any other purpose after sale.
- X. The successful bidder will also responsible for getting Registration Certificate of vehicle and/or any other documents as required by the RTO, in his name at his own Cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
- XI. **If successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the chassis number for this office immediately.**
- XII. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
