MEMORANDUM

The undersigned proposes to hold an inquiry against Shri Himanshu Chudhary, DEO Grade 'A' under Rule 14 of the Central Civil Services (Classification, Control and Appeal) Rules 1965. The substance of the imputations of misconduct or misbehaviour in respect of which the inquiry is proposed to be held is set out in the enclosed statement of Articles of Charge (Annexure I). A statement of the imputations of misconduct or misbehaviour in support of each Article of Charge is enclosed (Annexure II). A list of documents by which the Article of Charge is proposed to be sustained is enclosed (Annexure III). A list of witnesses is also enclosed (Annexure IV).


2. Shri Himanshu Chudhary, DEO Grade 'A' is directed to submit a written statement of his defence **within 15 days** of the receipt of this Memorandum and to state whether he desires to be heard in person.

3. He is informed that an inquiry will be held only in respect of those Articles of Charge as are not admitted by him. He should therefore specifically admit or deny each Article of Charge.

4. Shri Himanshu Chudhary, DEO Grade 'A', is further informed that if he fails to submit his written statement of defense on or before the date specified in Para 2 above or does not appear in person before the inquiring authority or otherwise fails or refuses to comply with the provisions of Rule 14 of the CCS (CCA) Rules, 1965, or the orders/directions issued in pursuance of the said rule, the Inquiring Authority may proceed with the inquiry against him ex-parte.

5. Attention of Shri Himanshu Chudhary, DEO Grade 'A' is drawn to Rule 20 of CCS (Conduct Rules) 1964, which states that no government servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interest in matters pertaining to his service under the government. If any representation is received on his behalf from any other person in respect of any matter dealt with in these proceedings, it will be construed that Shri Himanshu Chudhary, DEO Grade 'A' is aware of such representation and that it has been made at his instance and action will be taken against him for the violation of Rule 20 of CCS (Conduct Rules) 1964.

6. The receipt of the memorandum may be acknowledged.

STATEMENT OF ARTICLE OF CHARGE FRAMED AGAINST
SHRI HIMANSHU CHUDHARY, DATA ENTRY OPERATOR GRADE ‘A’

Article I

Shri Himanshu Chudhary, Data Entry Operator Grade ‘A’ of this office while on deputation to Headquarters Office has remained absent from duty unauthorizedly from 31.12.2024 to 29.07.2025. This action amounts to violation of provisions of Rule 3(ii), 3(iii), 3(xix) and 3 (xxi) of CCS (Conduct) Rules 1964.

Article II

Shri Himanshu Chudhary, Data Entry Operator Grade ‘A’ of this office was repatriated from deputation from Headquarters Office on 29.07.2025 with direction to report for duty in this office. This office issued recall memorandum vide letter no. ES1/A7/Deputation/I/1081837/2025 dt. 07.08.2025 and 02 reminders dt.19.08.2025 & 12.09.2025. However, Shri Himanshu Chudhary has neither furnished a reply explaining the reasons for his absence nor reported for duty. He remained absent form duty unauthorizedly from 30.07.2025 to 22.09.2025. This action amounts to violation of provisions of Rule 3(ii), 3(iii), 3(xix) and 3 (xxi) of CCS (Conduct) Rules 1964.

Article III

Shri Himanshu Chudhary, Data Entry Operator Grade ‘A’ of this office attended office for 19 days and again has remained absent from duty unauthorizedly from 27.10.2025 till date. This action amounts to violation of provisions of Rule 3(ii), 3(iii), 3(xix) and 3 (xxi) of CCS (Conduct) Rules 1964.

Article IV

Even though Shri Himanshu Chudhary, Data Entry Operator Grade ‘A’ of this office was given a **major penalty** of reduction to a lower stage in the time-scale of pay by five stages in Level 4 for a period of 05 years with cumulative effect after conclusion of disciplinary proceedings for unauthorised absence in 2023 and his earlier period of unauthorised absence being treated as “Dies non” without forfeiture of past service, he has exhibited the same behaviour with blatant disregard and violation of the provisions of Rule 3(ii), 3(iii), 3(xix) and 3 (xxi) of CCS (Conduct) Rules 1964 CCS (Conduct) Rules 1964.

Article V

Shri Himanshu Chudhary, Data Entry Operator Grade ‘A’ of this office was issued with Recall Memo No.AG (A&E)/Tappal AB/Genl/2025-26/202 dated 04.11.2025, 21.11.2025 & 15.12.2025, in response to which he has neither furnished a reply explaining the reasons for his absence nor reported for duty. This action amounts to violation of provisions of Rule 3(ii), 3(iii), 3(xix) and 3 (xxi) of CCS (Conduct) Rules 1964.


Article VI

Shri Himanshu Chudhary, Data Entry Operator Grade 'A' of this office was issued to submit Annual Property returns as required under Rule 18(2) of CCS (Conduct) Rules, 1964, vide this office Circular No. ES1/A4/2025-26/I/1209509/2025 dt. 24.11.2025 issued on 25.11.2025 and reminder issued on 21.01.2026 through email. However, he has not submitted his Annual Immovable Property Returns which is in violation of Rule 18(2) of CCS (Conduct) Rules, 1964 .

Shri Himanshu Chudhary, DEO Grade 'A' was issued with Show Cause Notice in No.CC/C1/2025-26/162 dated 24.12.2025. Despite being directed to reply within the stipulated time from issue of show cause notice, there has been no reply from the official to date.

By staying away from duty and not responding to the Show Cause Notice, Shri Himanshu Chudhary, DEO Grade 'A' has violated the provisions of Rule 7(1) of CCS (Leave) Rules,1972 which states that leave cannot be claimed "as a matter of right", Para 3.1, 3.2, 3.11 and 3.16 of the Manual of General Procedure, and also contravened the provisions of Rule 3 (1) (i) (ii) (iii) (xix) & (xxi) of CCS (Conduct) Rules 1964, which require every Government Servant shall at all times maintain absolute integrity, maintain devotion to duty, do nothing unbecoming of a Government Servant, maintain discipline in the discharge of his duties, and implement lawful orders communicated to him, perform and discharge his duties with the highest degree of professionalism and dedication to the best of his abilities.

Shri Himanshu Chudhary, DEO Grade 'A' has also violated Rule 3 (C) of the Government of India decision 23(8); acts and omissions amounting to "Habitual absence without permission and overstaying leave" of CCS (Conduct) Rules 1964 and warrants disciplinary proceedings under Rule 14 of CCS (CCA) Rules, 1965.

STATEMENT OF IMPUTATIONS OF MISCONDUCT / MISBEHAVIOUR IN SUPPORT
OF THE CHARGES FRAMED AGAINST SHRI. HIMANSHU CHUDHARY, DATA
ENTRY OPERATOR GRADE 'A'

A. Shri Himanshu Chudhary, Data Entry Operator grade 'A' has stayed away from duty unauthorisedly during the following spells.

1. From 31.12.2024 to 29.07.2025 (while on deputation to Headquarters Office)
2. From 30.07.2025 to 22.09.2025 (after repatriation from Headquarters Office)
3. From 27.10.2025 till date.

B. Shri Himanshu Chudhary, Data Entry Operator grade 'A' has not submitted Annual Property returns as required under Rule 18(2) of CCS (Conduct) Rules, 1964, amounting to violation of duty.

Headquarters office vide letter no. 2726/OE&Bills/Estt./127-2023 dt. 20.01.2026 has forwarded a copy of show cause notice to this office regarding unauthorised absence of Shri Himanshu Chudhary from 31.12.2024 to 29.07.2025. Further, a Show Cause Notice was issued to Shri Himanshu Chudhary, DEO Grade 'A' vide No.CC/C1/2025-26/162 dated 24.12.2025 to the last known address available in the records of this office. In the Show Cause Notice, he was directed to furnish a reply within a specified time from the date of receipt. However, Shri Himanshu Chudhary, DEO Grade 'A' has neither reported back to duty nor submitted any reply/explanation for his unauthorized absence during the aforementioned spells. He was directed to show cause as to why his absence from duty should not be treated as "unauthorized absence" and disciplinary proceedings under CCS (CCA) Rules, 1965, be initiated against him.

Even though Shri Himanshu Chudhary, Data Entry Operator Grade 'A' of this office was given a **major penalty** of reduction to a lower stage in the time-scale of pay by five stages in Level 4 for a period of 05 years with cumulative effect after conclusion of disciplinary proceedings for unauthorised absence in 2023 and his earlier period of unauthorised absence being treated as "Dies non" without forfeiture of past service, he has exhibited the same behaviour with blatant disregard and violation of the provisions of Rule 3(ii), 3(iii), 3(xix) and 3 (xxi) of CCS (Conduct) Rules 1964 CCS (Conduct) Rules 1964.

Shri Himanshu Chudhary, Data Entry Operator Grade 'A' of this office was issued with Recall Memos vide letters no. ES1/A7/Deputation/I/1081837/2025 dt. 07.08.2025 and 02 reminders dt.19.08.2025 & 12.09.2025. and vide letters no AG (A&E)/Tappal AB/Genl/2025-26/202 dated 04.11.2025, 21.11.2025 & 15.12.2025, in response to which the official has failed to respond to any official communication and has not submitted any leave application for his periods of unauthorized absences. By staying away from duty unauthorisedly and failing to respond to any of the earlier Recall Memos/Show Cause Notices, the official has contravened Rule 7(1) of CCS (Leave) Rules,1972 which states that leave cannot be claimed "as a matter of right", the provisions of Para 3.1, 3.2, 3.11, and 3.16

of the Manual of General Office Procedure and also violated the provisions of Rule 3 (1) (i) (ii) (iii) & (xix) of CCS (Conduct) Rules 1964 which requires every government servant shall at all times; maintain absolute integrity, maintain devotion to duty, do nothing which is unbecoming of a Government Servant, maintain discipline in the discharge of his duties and be liable to implement the lawful orders duly communicated to him. Shri Himanshu Chudhary, DEO Grade 'A' has also violated Rule 3 (C) Government of India decision 23(8) acts and omissions amount to misconduct; 'Habitual absence without permission and over-staying leave" of CCS (Conduct) Rules 1964.

Shri Himanshu Chudhary, Data Entry Operator Grade 'A' of this office was issued to submit Annual Property returns as required under Rule 18(2) of CCS (Conduct) Rules, 1964, vide this office Circular No. ES1/A4/2025-26/I/1209509/2025 dt. 24.11.2025 issued on 25.11.2025 and reminder issued on 21.01.2026 through email. However, he has not submitted his Property Returns which is in violation of Rule 18(2) of CCS (Conduct) Rules, 1964 .

Thus, he has violated Rule 7(1) of CCS (Leave) Rules,1972, Rules 3 (1) (i) (ii) (iii) & (xix) and Rule 18(2) of CCS (Conduct) Rules, 1964 and Government of India decision 23(8) under Rule 3(C) thereunder.



SHOW CAUSE NOTICE

It has been brought to the notice of the undersigned that your deputation tenure in the office of the Comptroller & Auditor General of India came to an end on **29.07.2025 (A.N.)** vide Headquarters Office letter No. 913/OE & Bills/Estt./144-2024 dated 29.07.2025. 
