CIRCULAR

Applications are invited from retired Supervisors(Accounts)/ Assistant Supervisors (Accounts)/Sr. Accountants/ Accountants against vacancies in the cadre of Accountant to work on short term contract basis in the office of the Accountant General (A&E), Odisha, Bhubaneswar in accordance with terms and conditions prescribed in Headquarters' Circular No.27/2021 issued with letter No.967-Staff(App I)/22-2016 dated 03.08.2021.

Tenure and age limit:

The retired officers can be hired on a short term contract basis initially up to a period of one year. The maximum number of terms is restricted to five. Further, no retired officer/official shall be hired beyond the age of 65 years.

Remuneration and Allowances:

Remuneration and allowances payable to retired officers/officials will be governed by OM No.3-25/2020-E.III A dated 09.12.2020 issued by the Department of Expenditure, Ministry of Finance, Government of India, New Delhi, which is as under:

- a) The retired officers/officials shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contact.
- b) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
- c) No annual increment / percentage increase, Dearness Allowance and House Rent Allowance shall be allowed during contract.

Leave:

Paid leave of absence shall be allowed at the rate of 1.5 days for each completed month of service to the retired officer/officials hired on short term contract basis.

Duties assignable and other conditions:

Duties assignable and other conditions shall be as envisaged in the Headquarters' Circular No.27/2021 dated 03.08.2021.

The retired officers/officials hired on short term contract basis shall sign an agreement of confidentiality containing a clause on Ethics and Integrity.

Retired officers/officials of the IA&AD fulfilling the eligibility criteria and willing for above assignments may submit their biodata. Applications duly filled in all respect must reach the undersigned by post or through e-mail at dagadmnae.od@nic.in latest by 30.11.2021 (Encl: Application Form).
