

### **AUCTION NOTICE FOR DISPOSAL OF E-WASTE**

This is to inform all the Recyclers/ Re-processors of e-waste, registered with Central Pollution Control Board/ State Pollution Control Board that a public auction of 236 no. of E-Waste (list enclosed as Annexure-I) i.e., Desktops, Printers, Laptops, etc. on "As is where is basis" will be held on 10.08.2024 (Saturday) at 11am.

Inspection of these items can be done from 01.08.2024 to 02.08.2024 during office hours (09:15 AM to 05:45 PM). Interested parties may submit their details by mail to <a href="mailto:cedpap.anp.ae@cag.gov.in">cedpap.anp.ae@cag.gov.in</a>, as prescribed in Annexure-II on or before 05.08.2024.

### 1. Eligibility criteria:

- a. The Participant must be registered as a Recycler/ Reprocessor/ Dismantler/ Collection/ Storage of e-waste with the Central Pollution Control Board or with the State Pollution Control Board.
- b. The Participant should not have been blacklisted by any Department of the Government of India or of any State/ or by any PSU/ Autonomous Organization of Government.

#### 2. General terms and conditions:

- a. The Participants may inspect the items on the prescribed dates and satisfy themselves with the items they are bidding for.
- b. The items would be sold to the firm that quotes the highest amount.
- c. An Earnest Money Deposit (EMD) of Rs.7959/- (Seven Thousand Nine Hundred and Fifty-Nine) in form of Demand Draft/ Banker's Cheque in favour of "Sr. Accounts Officer, Bills, O/o PAG(A&E), Andhra Pradesh" should be submitted on the day of auction.
- d. The successful vendor will have to pay the entire quoted amount within five working days after receipt of confirmation, in the form of Demand Draft/ Cheque drawn in favour of "Sr. Accounts Officer, Bills, O/o PAG(A&E), Andhra Pradesh".
- e. The successful vendor shall be required to shift all the items from the site within five working days after the payment. On failure to do so, O/o PAG(A&E) shall have the right to forfeit the entire amount and dispose the items to alternate vendor.
- f. No items, once disposed, shall be taken back under any circumstances.
- g. All miscellaneous charges like transportation, labour, or any other expenses, etc. shall be borne by the vendor.
