# <u>Terms and Conditions for Pest Control, Rodent Control and One time anti-termite treatment.</u>

## 1. Scope of Work

The pest control service provider should agrees to perform pest control treatment as per the following description of work, ensuring compliance with all applicable government standards and regulations for central government premises.

Sr. No.	Type of Services	Area(in Sq.mtr)	Frequency
01.	General Pest Control	2,526	Monthly
02.	Rodent Control	14,748	Half yearly
03.	Anti Termite	3,541	Once in a year

#### 2. Qualification Condition

- The bidder should have registered office in Nagpur city ,documentary evidence to be submitted.
- Bidder must have experience of execution of similar nature of work in past in any Govt/PSU offices.
- Bidder must have license to execute pest control.
- The selected agency shall submit a Security Deposit equivalent to 3% of contract value in the shape of F.D.R/Account payee demand draft, bank guarantee in the name of Sr. Accounts Officer/L&S-I, office of the Accountant General (A&E)-II, Maharashtra, Nagpur for the contract period. The same shall be submitted to this office within a week from the date of receipt of work order. In the case of unsatisfactory service the amount of security shall be forfeited.

#### 3. Access and Permission

- The Service Provider shall have access only to authorized areas within the premises during the scheduled treatment times.
- Entry permissions will be coordinated with the designated government official or department representative.

#### 4. Treatment Schedule

- Pest control treatments will be carried out according to a mutually agreed schedule.
- Any changes in schedule must be communicated at least 48 hours in advance.

## 5. Safety and Compliance

• The Service Provider must use only government-approved, environmentally safe, and non-toxic chemicals and materials.

- All treatments shall comply with the Health, Safety, and Environmental (HSE) guidelines applicable to government properties.
- The Service Provider shall ensure no harm to personnel, visitors, or government property.

#### 6. Pre-Treatment Precautions

- The Service Provider will advise the premises occupants about necessary precautions before treatment, including evacuation of areas if required.
- The Service Provider shall place appropriate warning signs and barriers during and after treatment as necessary.

## 7. Liability and Indemnity

- The Service Provider shall be responsible for any damage caused to the premises or government property due to negligence or improper treatment methods.
- The Service Provider shall indemnify and hold harmless the government from any claims arising out of injury, loss, or damage caused by the treatment.

# 8. Confidentiality

• All information related to the premises, operations, or government activities encountered during the course of work shall be treated as confidential.

#### 9. Termination

- The government/competent authority of the office reserves the right to terminate the contract if the Service Provider fails to comply with any of the terms, fails to meet the quality standards, or causes safety concerns.
- Notice of termination will be provided in writing with immediate effect in case of any major breach.

# 10. Payment Terms

• Payments will be made quarterly upon satisfactory completion of the treatment and submission of necessary reports/invoices.

# 11. Reporting

- The Service Provider shall provide detailed reports post-treatment, including chemicals used, areas treated, and any recommendations for follow-up.
- **12. Penalty:** Penalty will be imposed at the following rates for absence of Contractor's minimum nos. of workers.
  - Absence of worker @ 500/- per day.

- If Work is not completed within the time Frame 500 Per Day
- Further in case of complaint's, penalty as below will be imposed.
- In minor complaints If the firm does not attend within 24 hrs of the lodging of complaint, a penalty of Rs. 500/- per day will be imposed till the defect is rectified.
- In major complaints-If the firm does not attend within 48 hrs of the lodging of complaint, a penalty of Rs. 1000/- per day will be imposed till the defect is rectified.

## 13.Breach of Contact/Agreement:

In case of breach of any terms and conditions as mentioned above, the Competent Authority will have the right to cancel Contract Agreement without assigning any reasons thereof and nothing will be payable by AG Office, Nagpur. In that event the security deposit shall also stand forfeited.
