**Subject**: Blacklisting of M/s Prakriti Interiors, M/s. Furniture.COM, M/s. Krishna construction Co. and M/s. Space Explorers

The office of the Comptroller and Auditor General of India, has observed that the following firms were engaged in anti-competitive practices including collusion and bid-rigging:

- i. M/s. Prakriti Interiors,
- ii. M/s. Furniture.com
- iii. M/s. Krishna Construction Co and;
- iv. M/s. Space Explorers.

It was observed that the aforementioned firms are owned by family members of the same family, which is explained as below:

Prakriti Interiors	Kriti Dhiman	Daughter-in- law of Surjeet Singh	152 orders of `50.06 lakh

Hence, it can invariably be presumed that with prior knowledge and mutual understanding, all the above firms had participated in procurement process as well as execution of the resultant contract.

In terms of General Financial Rules 175, 2017 and Dept. of Expenditure OM No F.1/2018-PPD dated 2nd November 2021, the firm M/s. Krishna construction Co. was issued a show cause notice vide email dated 12 February 2025, requesting their response why the firms should not be debarred from further bidding process in this organisation. A reminder was subsequently sent on 17 March 2025. The firms were given a reasonable opportunity to represent against such debarment. However, no response is received from the firms.

AND THEREFORE, the firms M/s Prakriti Interiors, M/s. Furniture.COM, M/s. Krishna construction Co. and M/s. Space

Explorers are hereby blacklisted and debarred from entering any contracts with this office for three years from the issue of this letter.
