Several prospective respondents have indicated that certain queries raised during the pre-bid period were not fully addressed through the written responses published in Corrigendum No. 01, and have sought an opportunity for interactive clarification. 3. SCOPE AND PURPOSE OF THE MEETING

- The meeting will not be recorded. Minutes / summary of significant clarifications, if any, will be published on the CPPP portal as a Corrigendum.

- Participation in the pre-bid meeting is optional and does not affect a respondent's eligibility to submit an EOI response.
- CAG reserves the right to decline any query that falls outside the scope of the EOI or that seeks commitments in advance of the RFP.

- The last date for submission of EOI responses remains 09 June 2026 at 5:00 PM IST as notified in Corrigendum No. 02. This meeting does not alter the submission deadline.
