- 2. The Vendor shall offer/provide 4G facility and undertake to provide the upcoming 5G facility.
- 3. The annual data plan should have minimum daily download of 2 GB data as per the best offered speed (10 Mbps or higher) without any speed downgrade and thereafter unlimited download on normal speed (5 Mbps or higher).
- 4. Technical specifications of the data Cards be specified along with its tender.
- 5. Data Card Dongle should be plug & play on all variants of UBUNTU LINUX (12.04 & above), Red Hat Enterprise Linux (3.5 and above), Windows (XP and above) and Macintosh (Mac OS X and above) Operating Systems.

- 5. Copy of satisfactorily executed supplies/similar projects in the past.
- 6. Copy of certificate assuring the network strength in remote localities of Himachal Pradesh.
- 7. Best offered speed of 10 Mbps or higher and Normal speed (beyond download limit) of 5 Mbps or higher.
- 8. 4G facility and upgradability for 5G network.
- **9.** <u>**Preferred Item:**</u> Network availability sheet for all locations in all districts of Himachal Pradesh wherever towers of service provider are installed with the specifications of minimum and maximum speed offered at that particular location.
