1. The firm must enclose an EMD of Rs. 50000/- (Rupees fifty thousand only) in form of DD of any nationalized bank in favour of Pay and Accounts Officer, O/o the AG(A&E)-I,U.P., Prayagraj alongwith the tender.
2. The bids should be in two parts i.e., Technical and Financial bid in the attached prescribed form (annexed as Annexure I & II) for supply of Network Attached Storage Server.
3. The specifications of the Network Attached Storage Server is mentioned in Annexure-1
4. The Firms should clearly mention their Eligibility as per the eligibility criteria in Annexure-2.
5. The Financial bid should mention their quoted rate in the prescribed format provided in Annexure-3 considering all the terms and conditions listed in the tender enquiry.
6. The tenders may please be addressed and sent to SENIOR DEPUTY ACCOUNTANT GENERAL (ADMINISTRATION), O/o PRINCIPAL ACCOUNTANT GENERAL (AUDIT-I), U.P., 15-A, Dayanand Marg, PRAYAGRAJ-211001. The technical and financial bid should be in two separate sealed covers and the envelope should indicate clearly the nature of bid contained in the envelope viz. Technical bid or Financial bid for maintenance of Servers/Desktop Computers/laptops/Printers and Other Peripherals on the top of the envelope. Both envelopes should be kept in a single envelope addressed to authorized recipient. Envelop should reach on or before 21/01/2026 (03:00 PM). All the tenders received, will be kept in the box under the custody of SENIOR DEPUTY ACCOUNTANT GENERAL (ADMINISTRATION), IIND FLOOR, O/O PAG (AUDIT-I), U.P., PRAYAGRAJ placed in his chamber for this purpose.

TECHNICAL SPECIFICATIONS OF THE SERVER

The Network Attached Storage Server to be supplied should be of the following technical specifications mentioned below:

Annexure-2

FORM OF TECHNICAL BID

TERMS AND CONDITIONS FOR SUPPLY OF NETWORK ATTACHED STORAGE SERVER.

Eligibility criteria for the bidders:

The following documents are required from Bidder :

1. The bidder should have experience of supply of server in Government or Semi-Government or Public Sector Undertakings during the last five years. For this the bidder should attach copy of invoices/acceptance certificates as proof of supply.
2. The bidder should be registered with the Registrar of Companies or Registrar of Firm and submit a copy of the Registration.
3. The bidder should submit its PAN no. and GST no. with the bid and enclose latest Income tax returns and GST returns.
4. The minimum average annual turnover of the bidder for the past three years should not be less than ₹ 12,00,000.00 (Rupees twelve lakh) per annum. For this the bidder should attach copies of financial statements (balance sheets) of the past three years.
5. The minimum average annual turnover of the OEM for the past three years should not be less than ₹ 1,00,00,000.00 (Rupees one crore) per annum. For this, the bidder should attach copies of financial statements (balance sheets) of the past three years.
6. The bidder should submit a copy of acceptance of each of the technical specifications mentioned in Annexure-1 and should not declare any deviations from the prescribed specifications of the server.
7. The bidder must provide a warranty of 60 months from date of supply and installation of the server.

9. The bidder should never have been blacklisted from any Government office/Agency and should submit a certificate of declaration regarding the same.
10. The firm must enclose an EMD of ₹ 50000/- (Rupees fifty thousand only) in form of DD of any nationalized bank in favour of **Pay and Accounts Officer, O/o the AG(A&E)-I,U.P., Prayagraj** along with the tender.
11. The firm must submit a performance security of an amount equal to ***three percent*** of the contract value of the supply of the aforesaid equipment. The performance security shall in the form of DD or Bank Guarantee valid for minimum 12 months of any nationalized bank in favour of **Pay and Accounts Officer, O/o the AG(A&E)-I,U.P., Prayagraj.**
12. Bidders may ignore the Make and Model published in the bid. Bidders can quote Storage Server of preferably HP, Dell and Cisco make with specifications fully complied as per tender specifications. No deviation of any type shall be accepted for technical specifications.
13. In case bidder is seeking exemption from Experience/Turnover Criteria/EMD Exemption, the supporting documents to prove his eligibility for exemption must be attached for evaluation by the organization. Failure to do so will result in disqualification of the bidder.
14. Bidder must supply the ordered material within 7 business days of award of purchase order failing which the order shall be treated as cancelled.
15. Bidder must provide details datasheet of the quoted product.
16. Bidder must provide point wise technical compliance on their letterhead with sign and stamp.
